WHEREAS, This Resolution is filed with the Rensselaer County Legislature by the Rensselaer County Executive; and

WHEREAS, An incident involving a water leak occurred at the Troy Senior Center located at 1520 6th Avenue, Troy, New York;

WHEREAS, The County's insurance provider has offered a settlement to cover the costs of mitigation and repairs for said damages; and

WHEREAS, An insurance settlement check in the amount of \$17,704.30 has been received by Rensselaer County for the total loss, less the deductible, and the Department seeks to use the funds to replenish the Department's budget for that portion of the expenses incurred for the building repair; now, therefore, be it
