**RESOLUTION AUTHORIZING AN AGREEMENT WITH MOTOROLA SOLUTIONS FOR THE
PURCHASE OF THREE (3) RADIO CONSOLES AND TOWER SECURITY AND MONITORING
UPGRADES, CREATION OF A CAPITAL ACCOUNT AND AMENDING THE 2025
RENSSELAER COUNTY ADOPTED BUDGET - BUREAU OF PUBLIC SAFETY**

WHEREAS, This Resolution is filed with the Rensselaer County Legislature by the Rensselaer County Executive; and

WHEREAS, The Bureau of Public Safety ("Bureau"), in collaboration with the Town of East Greenbush, has identified a critical need to enhance the County's emergency communication infrastructure by installing three (3) replacement Motorola radio consoles and related accessories at the East Greenbush Police Department, which serves as an instant backup site for the County; and

WHEREAS, This project also includes a significant security and monitoring upgrade for the County's radio tower sites, ensuing enhanced reliability, operational security, and system integrity for emergency communications; and

WHEREAS, Motorola Solutions, the County's chosen radio vendor has provided a proposal for this project (NYS CONTRACT - PT68722) in the amount of \$520,000.00; and

WHEREAS, The Town of East Greenbush has entered into a Memorandum of Understanding with the County and is responsible to contribute \$255,000.00 payable to the County for the project costs; and

WHEREAS, The Bureau has identified the following budget codes from which funds will be transferred into newly created Capital Project Fund Accounts, which are as detailed: A.3640.02400.EMPG.2024.02400 \$61,723.00, A.3640.02400.SICG.2023.02400 \$118,277.00, and A.3640.02400.SHS.2024.02400 \$85,000.00; now, therefore, be it

RESOLVED, That the Bureau of Public Safety is authorized to create Capital Project Fund Accounts for the purpose of funding this project; and, be it further

RESOLVED, That the Rensselaer County Executive, or his designee, is authorized to sign agreements or documents to facilitate the completion of this project in coordination with the Town of East Greenbush and the Bureau of Public Safety, subject to the approval as to form by the Rensselaer County Attorney; and, be it further

WHEREAS, Article 9 of the New York Energy Law (the "Act") authorizes municipalities and school districts to enter into contracts ("Energy Performance Contracts") for the provision of energy services, including but not limited to, electricity, heating, ventilation, cooling, steam or hot water, in which a person agrees to install, maintain, or manage energy systems or equipment to improve the energy efficiency of, or produce energy in connection with, a building or facility in exchange for a portion of the energy savings or revenues; and

WHEREAS, Rensselaer County (the "County") issued a Request for Proposals (RFP-13-37) for a performance-based energy savings and operations plan for various county facilities; and

WHEREAS, Based on the evaluation of the proposals, Siemens Industry, Inc. ("Siemens") was selected to develop and implement a performance-based energy savings and operations plan; and

WHEREAS, Siemens has provided the County with a proposal for the 116 Pinewoods Avenue Property (the "Proposal") which sets forth certain energy performance and related facility improvement measures for the property; now, therefore, be it

RESOLVED, By the County Legislature of Rensselaer County, New York, as follows:

Section 1. In accordance with Section 9-103 of the Act, the County is hereby authorized to enter into an amendment to energy performance contract with Siemens and related lease/purchase agreements and other agreements with Siemens Public, Inc. (collectively the "Agreements"), in an additional principal amount not to exceed amount of \$2,333,469.00, plus interest and annual program payments not to exceed \$11,864 in any one year, in connection the work related to the Proposal, pursuant to which Siemens will provide equipment and other services to improve the energy efficiency of the 116 Pinewoods Avenue Property, as more particularly described in the Proposal and to pay reasonable costs of issuance relating to the Agreements.

Section 2. The Chief Fiscal Officer, as Chief Fiscal Officer of the County, is hereby authorized to negotiate and deliver on behalf of the County the Agreements and all other certificates or instruments required in connection therewith provided, however, that all amounts payable by the County pursuant to the Agreements shall be subject to annual appropriation of such payments by the County Legislature. The power to prescribe the terms, forms and covenants of the Agreements is hereby delegated to the Chief Fiscal Officer, as Chief Fiscal Officer.

Section 3. This Resolution is intended to constitute the declaration of the County's "official intent" to reimburse the costs of the improvements described in Section 1 of this resolution with proceeds from the Agreements with Siemens, as required by Treasury Regulation Section 1.150-2.

Section 4. This Resolution is not subject to a mandatory or permissive referendum.

Section 5. The County hereby determines that the provisions of the State Environmental Quality Review Act and the regulations thereunder have previously been satisfied with respect to the expenditures authorized by this Resolution.

Section 6. All acts previously taken by the County with respect to the execution and delivery of the Agreement are hereby further authorized, with the assistance of, and subject to the approval of the County Attorney, ratified and confirmed.

Section 7. This Resolution shall take effect immediately.

WHEREAS, The Rensselaer County Correctional Facility utilizes a direct supervision management style, a somewhat unique departure from traditional jails but one which has proven to be a safer method of managing inmate populations; and

WHEREAS, The housing pods are open, self-contained living units which house between 40 and 60 inmates. This architectural design enhances supervision, increases perimeter security and effectively divides inmates into manageable groups, resulting in an efficient, well-run, and safe environment for the staff, inmates, visitors and the general community; and

WHEREAS, The Correctional Officers are essential to the day-to-day operations and without them it would be impossible to achieve the foremost institutional goals of safety, security and order; and

WHEREAS, The professionalism, dedication and courage exhibited by these officers throughout the performance of these demanding and often conflicting roles deserve our utmost respect; and

WHEREAS, The important work of Correctional Officers often does not receive the recognition from the public it deserves; now, therefore, be it

RESOLVED, That Rensselaer County Legislature commends the many contributions and accomplishments of these men and women who are a vital component of the Rensselaer County Correctional Facility and designate the week of May 5th - 11th, 2024 as Correctional Officers Week in Rensselaer County; and, be it further

RESOLUTION RECOGNIZING MAY 23, 2025 AS NATIONAL POPPY DAY

WHEREAS, Symbols are important because they facilitate communication and identification of ideas and other concepts based on what those symbols represent; and

WHEREAS, The red poppy is a nationally recognized symbol of sacrifice and remembrance worn by Americans since World War 1 in honor of those who have served and died for our Country in all wars; and

WHEREAS, After World War 1 the Poppy became abundant in Europe and scientists attributed the growth to the soil becoming enriched with lime from the rubble left by the war; and

WHEREAS, The Poppy came to symbolize the blood shed during battle following the publication of the wartime poem "In Flanders Fields" written by Canadian Lt. Col. John McCrae, a medical doctor, while serving on the front lines, "In Flanders Fields the poppies blow, between the crosses row on row, that mark our place and in the sky, the larks, still bravely singing, fly scarce heard amid the guns below"; and

WHEREAS, Monia Michael, teacher from Monroe, Georgia, was in Germany when World War 1 broke out; and

WHEREAS, Returning to the United States, Monia took a leave of absence and volunteered to assist in the New York based training headquarters for overseas YWCA workers; and

WHEREAS, On November 9, 1918, inspired John McCrae's poem, Monia wrote a poem in response called "We Shall Keep the Faith". The third stanza reads "And now the Torch and Poppy Red we wear in honor of our dead. Fear not that ye have died for naught; We'll teach the lesson that ye wrought In Flanders Fields" vowing to always wear a red poppy as a symbol of remembrance for those who served in the war; and

WHEREAS, After the war was over, Monia returned to the University of Georgia and taught a class of disabled servicemen; realizing the need to provide financial and occupational support for these servicemen, she pursued the idea of selling silk poppies as a means of raising funds to assist disabled veterans; and

WHEREAS, In 1921, her efforts resulted in the poppy being adopted as a symbol of remembrance for war veterans by the American Legion Auxiliary; and

WHEREAS, In 2017, the American Legion called upon Congress to designate the Friday before Memorial Day as National Poppy Day; now, therefore, be it

RESOLVED, The Rensselaer County Legislature does hereby pause in its deliberations to designate May 23, 2025 as National Poppy Day and encourages everyone to wear a Red Poppy in memory of the fallen and in support of the living who have worn our Nation's uniform.

WHEREAS, Expanded natural gas access helps keep energy prices low by increasing supply, 98 percent of the natural gas used in the United States is produced in North America; and

WHEREAS, 60 percent of New York households heat with natural gas, and 40 percent of the state's electricity comes from natural gas power plants, making it essential to daily life; and

WHEREAS, Equally as important as reliability is cost. Twenty-five percent of current utility bills are made up of taxes and fees used to fund renewable energy. With more mandates coming online as a result of the passage of and the implementation of the Climate Leadership and Community Protection Act (CLCPA), these on-bill costs are set to increase further; and

WHEREAS, The NY HEAT Act threatens to increase energy costs, eliminate critical jobs, and compromise the reliability of the energy grid; now, therefore, be it

RESOLVED, That the Rensselaer County Legislature strongly urges Governor Kathy Hochul to oppose the NY HEAT Act and any legislation that increases energy costs, eliminates vital jobs, and weakens the state's energy system; and, be it further
