WHEREAS, This Resolution is filed with the Rensselaer County Legislature by the Rensselaer County Executive; and

WHEREAS, The "Raise the Age" (RTA) legislation raises the presumptive age of juvenile accountability for sixteen (16) year-olds effective October 1, 2018 and for seventeen (17) year-olds effective October 1, 2019; and
