A local law **A LOCAL LAW PROVIDING THE MAXIMUM TERM FOR WHICH THE COUNTY LEGISLATURE OF RENSSELAER COUNTY MAY ENTER INTO A GROUND LEASE OF REAL PROPERTY OWNED BY RENSSELAER COUNTY**

Be it enacted by the County Legislature of the
(Name of Legislative Body)

County of Rensselaer as follows:

Pursuant to Section 10 of the Municipal Home Rule Law

Section 1. Forty Year Term

Notwithstanding Section 215 of the New York State County Law, the County Legislature of Rensselaer County is hereby authorized to lease pursuant to a ground lease agreement real property owned by Rensselaer County for an original term not to exceed forty years. Any such ground lease agreement may provide for the renewal thereof, provided that the term of each such renewal shall not exceed forty years.

Section 2. Severability

If any article, section, subsection, paragraph, phase or sentence of this local law is for any reason held invalid or unconstitutional by any court of competent jurisdiction, that portion shall be deemed a separate district, and independent provision and such holding shall not affect the validity of the remaining portion hereof.

Section 3. Effective Date

This local law is adopted subject to permissive referendum pursuant to Section 24 of the New York State Municipal Home Rule.

WHEREAS, The Bureau of Tax Services ("Department") seeks Legislative approval to renew an agreement with Applied Business Systems, Inc. for Printing, Folding and Mailing Services; and

WHEREAS, The proposed agreement will enable Rensselaer County, Towns, and Schools to utilize the services being provided; and

WHEREAS, This Resolution is filed with the Rensselaer County Legislature by the Rensselaer County Executive; and

WHEREAS, Rensselaer County Bureau of Public Safety has been awarded the SFY2025 Next Generation 911 Grant (NG911) from the New York State Division of Homeland Security and Emergency Services for the period of September 1, 2025 through August 31, 2030 in the amount of \$1,639,396.00; and

WHEREAS, The grant will provide funding to the Bureau of Public Safety Emergency Communications Center "911 Center" for critical 911 phone system upgrades; now, therefore, be it

RESOLVED, That any positions, programs, expenditures and/or agreements or contracts authorized or established pursuant to this resolution shall terminate and cease upon discontinuance of said funding; and, be it further

**RESOLUTION OF THE COUNTY OF RENSSELAER, NEW YORK AUTHORIZING THE AMENDMENT OF
ENERGY PERFORMANCE CONTRACT WITH SIEMENS INDUSTRY, INC., FOR IMPROVEMENTS AT
THE VAN RENSSELAER MANOR - VAN RENSSELAER MANOR**

WHEREAS, This Resolution is filed with the Rensselaer County Legislature by the Rensselaer County Executive; and

WHEREAS, The Van Rensselaer Manor ("Manor"), located in North Greenbush, NY, is a well-respected skilled nursing and rehabilitation facility that has served the Rensselaer County community for over 65 years; and

WHEREAS, The 362-bed long-term nursing care facility was built in 1996 and is operated by the Rensselaer County Department of Social Services; and

WHEREAS, The County of Rensselaer ("County") has recognized the importance of maintaining and modernizing its facilities and infrastructure for the benefit of its residents and overall community; and

WHEREAS, The County has sought and has received the authority from the New York State Department of Health to transform and improve the Manor from its current hospital-like environment, characterized by outdated décor and amenities, into a welcoming, energy efficient residential-style space; and

WHEREAS, The County proposes to embark upon the comprehensive renovation of the Manor to enhance the quality of life for its residents, improve the working conditions for staff and ensure the facility remain operable for the residents of Rensselaer County for future years to come (the "Project"); and

WHEREAS, Article 9 of the New York Energy Law (the "Act") authorizes municipalities and school districts to enter into contracts for the provision of energy services, including but not limited to, electricity, heating, ventilation, cooling, steam or hot water, in which a person agrees to install, maintain, or manage energy systems or equipment to improve the energy efficiency of, or produce energy in connection with, a building or facility in exchange for a portion of the energy savings or revenues; and

WHEREAS, The County issued a Request for Proposals (RFP-13-37) for a performance-based energy savings and operations plan for various county facilities; and

WHEREAS, Based on the evaluation of the proposals, Siemens Industry, Inc. ("Siemens") was selected to develop and implement a performance-based energy savings and operations plan; and

WHEREAS, Siemens has provided the County with an energy and operational audit titled "Facility Improvement Measures for the County of Rensselaer Van Rensselaer Manor Nursing Home - Phase 4 85 Bloomingrove Drive, Troy, NY 12180", dated July 21, 2025 ("Report"), that sets forth an overview and scope of work for the Project; and

WHEREAS, The estimated cost of the Project is \$111,742,513.00, which includes comprehensive renovations, improvements and energy efficient upgrades to every facet of the existing facility, both interior and exterior, not limited to the entry lobby and reception area, the business office wing, kitchen and nursing station, common amenity spaces, resident rooms, bathroom facilities, laundry accessories, building exteriors and existing courtyards; now, therefore, be it

RESOLVED, By the County Legislature of Rensselaer County, New York, as follows:

Section 1. In accordance with Section 9-103 of the Act, the County is hereby authorized to enter into a contract amendment with Siemens (the "Agreement") in the amount of \$111,742,513.00, together with performance assurance program payments not to exceed \$10,613 in any one year plus annual maintenance services program payments not to exceed \$923,457 in any one year for mechanical, fire alarm, building automation, and security, in connection the work related to the Project, pursuant to which Siemens will provide equipment and services to improve the building substructure of the Van Rensselaer Manor, as more particularly described in the Report.

Section 2. The Chief Fiscal Officer, as Chief Fiscal Officer of the County, is hereby authorized to negotiate and deliver on behalf of the County the Agreement and all other certificates or instruments required in connection therewith, subject to the approval as to form by the County Attorney, and provided, that all amounts payable by the County pursuant to the Agreement shall be subject to annual appropriation of such payments by the County Legislature. The power to prescribe the terms, forms and covenants of the Agreements is hereby delegated to the Chief Fiscal Officer, as Chief Fiscal Officer.

Section 3. This Resolution is not subject to a mandatory or permissive referendum.

Section 4. The County hereby determines that the provisions of the State Environmental Quality Review Act and the regulations thereunder have previously been satisfied with respect to the expenditures authorized by this Resolution.

Section 5. All acts previously taken by the County with respect to the execution and delivery of the Agreement are hereby further authorized, ratified and confirmed.

Section 6. This Resolution shall take effect immediately.

WITH THE U.S. ECONOMIC DEVELOPMENT ADMINISTRATION GRANT FOR THE HUDSON
VALLEY COMMUNITY COLLEGE APPLIED TECHNOLOGY EDUCATION CENTER (ATEC)
PROJECT - BUREAU OF ECONOMIC DEVELOPMENT AND PLANNING**

WHEREAS, Hudson Valley Community College ("HVCC"), sponsored by Rensselaer County (the "County") under Article 126 of the New York Education Law, is constructing the Applied Technology Education Center ("ATEC" or the "Project") on a portion of the County-owned real property located at 80 Vandenburg Avenue, Troy, New York (the "Property"); and

WHEREAS, By Resolution G/358/21, adopted October 13, 2021, this Legislative Body authorized the County to finance up to \$2,960,000 in engineering and design costs for the Project through the Rensselaer County Capital Resource Corporation; and

WHEREAS, By Resolution G/322/22, adopted August 9, 2022, this Legislative Body further authorized the County to provide in-kind contributions, including legal and engineering support, demolition assistance, and paving services, in support of the Project; and

WHEREAS, HVCC has been awarded a \$4,000,000 grant from the U.S. Economic Development Administration ("EDA") under Project No. ED23PHG0159, pursuant to Public Law 108-373, 42 U.S.C. § 3121, et seq. (the "Award"); and

WHEREAS, A condition of the Award requires the execution and recording of a "Covenant of Purpose, Use and Ownership" (the "Covenant") that restricts the use and disposition of the Property for the estimated useful life of the Project (20 years), in accordance with 13 C.F.R. Part 314 and 15 C.F.R. Part 24, to ensure the Property is used solely for authorized Project purposes and to protect the federal interest; and

WHEREAS, The Covenant, in draft form attached hereto as Exhibit A, identifies Rensselaer County as both "Recipient" and "Sponsor," imposes no alienation of title, runs with the land, and requires recording in the Rensselaer County Clerk's Office; and

WHEREAS, The Property is owned in fee by Rensselaer County, and the Covenant constitutes a permissible restriction on county-owned real property in furtherance of a valid public purpose—namely, securing federal funding for workforce development, advanced manufacturing training, and economic growth within Rensselaer County; and

WHEREAS, Under New York County Law § 215 and the Rensselaer County Charter (§§ 2.02, 2.05), this Legislative Body holds authority to approve encumbrances and long-term commitments affecting county real property; and

WHEREAS, The HVCC Office of General Counsel, by letter dated November 22, 2024, has indicated that the County is required to be a party to execute and record the Covenant, noting that Legislative approval is required to effectuate any lien or restriction on county-owned land; and

WHEREAS, The Project has received a Negative Declaration under the State Environmental Quality Review Act (SEQRA), attached to the November 22, 2024 letter, confirming no significant adverse environmental impacts; now, therefore, be it

RESOLVED, That the Rensselaer County Legislature hereby finds that execution and recording of the Covenant serves a legitimate public purpose by enabling receipt of \$4,000,000 in federal funding for the ATEC Project, which supports education, workforce training, and economic development within the County; and, be it further

RESOLVED, That the Rensselaer County Executive, or his designee, is hereby authorized and directed to execute, on behalf of Rensselaer County, the Covenant of Purpose, Use and Ownership in substantially the form attached hereto as ****Exhibit A****, with such non-material modifications as may be approved by the Rensselaer County Attorney; and, be it further

RESOLVED, That the Rensselaer County Executive, or his designee, is authorized to cause the executed Covenant to be duly acknowledged and recorded in the Office of the Rensselaer County Clerk, and to deliver a certified recorded copy to the U.S. Economic Development Administration as required under the Award; and, be it further

RESOLUTION OPPOSING THE CONSTRUCTION OF A PROPOSED NATIONAL GRID NATURAL GAS TRANSFER STATION ON SPRING AVENUE IN BRUNSWICK, NY

WHEREAS, This Legislative Body has a record of advocating for the best interests in protecting and improving the quality of life of those who live and work in Rensselaer County; and

WHEREAS, National Grid has proposed the construction of a natural gas transfer station on approximately 11-12 acres off Spring Avenue in Brunswick, NY, near Pleasantview Avenue, Menemsha Lane, and Creek Road; and

WHEREAS, The proposed facility would include infrastructure to supplement the regional natural gas system, with potential impacts on air quality, noise levels, traffic, and public safety; and

WHEREAS, The proposed site is located in a residential area, raising concerns among residents about the proximity of industrial operations to homes, schools, and recreational space; and

WHEREAS, The proposed facility would house approximately 26 compressed natural gas (CNG) tankers, with the potential to accommodate up to 32 tankers, each storing gas at pressures between 3,000 and 3,600 PSIG, posing inherent safety risks including the potential for explosion, despite the rarity of such incidents; and

WHEREAS, The proposed site would require continuous lighting and generate increased noise during periods of operation, thereby disrupting the quality of life and peace of nearby residents; and

WHEREAS, The proposed transportation route for CNG tankers would direct heavy truck traffic through the City of Troy – specifically along Ferry Street, Congress Street, and Pawling Avenue – introducing large industrial vehicles onto roads with pedestrian traffic, limited shoulders, and residential character, thereby increasing safety risks and traffic congestion; and

WHEREAS, The facility is intended to operate primarily during periods of extreme cold, which National Grid representatives have stated occur only two to three times per decade, yet the tankers would remain on-site from Fall through Spring regardless of actual usage, raising concerns about the necessity and permanence of the installation; and

WHEREAS, Community members have not received sufficient assurances or regulatory guarantees that the facility's use will remain limited to rare cold weather events, nor has there been clarity on whether future operational expansion could occur without additional public input or oversight and expressed strong opposition to the project, citing environmental risks, lack of transparency, and insufficient public engagement in the planning; and

WHEREAS, In 2019 Governor Andrew Cuomo signed the Climate Leadership and Community Protection Act (CLCPA), a State mandate requiring the reduction of greenhouse gas emissions by 85% by 2050, the generation of 75% renewable energy by 2030, and the achievement of 100% zero-emission electricity by 2040, including the elimination of existing fossil-fuel-fired sources such as natural gas; and

WHEREAS, In 2022, this Legislative Body adopted a resolution acknowledging the far-reaching and ambitious goals of the CLCPA, recognizing New York's commitment to clean energy and greenhouse gas reduction, while also expressing concern regarding the substantial and yet-undisclosed costs that will ultimately be passed on to New York residents, noting testimony from Public Service Commissioner John Howard that the CLCPA may result in hundreds of billions of dollars in higher utility rates; and

WHEREAS, The Climate Leadership and Community Protection Act directs state agencies and regulated utilities to prioritize decarbonization, reduce reliance on fossil fuels, and avoid new infrastructure that would expand or prolong the use of natural gas, and therefore the construction of a compressed natural gas (CNG) transfer station directly conflicts with the intent of the Climate Act by increasing dependency on fossil fuel infrastructure rather than advancing clean energy and emission-free alternatives; and

WHEREAS, The Town of Brunswick Planning Board is currently reviewing site plan approval and a special use permit for the facility; and

WHEREAS, This Legislative body is committed to protecting and ensuring that our neighborhoods are safe and healthy places to live and that we protect them from any entity that will jeopardize their quality of life; now, therefore, be it

RESOLVED, That we urge the Brunswick Planning Board and other relevant authorities to deny the special use permit and site plan approval for this project; and, be it further

RESOLVED, That we call upon National Grid to explore alternative locations and technologies that do not compromise the health, safety, and character of our community; and, be it further

RESOLVED, That we request increased transparency, public hearings, and environmental impact assessments before any further action is taken on this proposal; and be it further

RESOLVED, That this resolution be submitted to the Town of Brunswick, the City of Troy, Rensselaer County officials, the New York State Public Service Commission, and other relevant regulatory bodies to urge a full and transparent review of the project, including comprehensive environmental and safety assessments, and to advocate for the protection of residential communities from industrial encroachment.


