WHEREAS, This Resolution is filed with Rensselaer County Legislature by the Rensselaer County Executive; and

WHEREAS, The Rensselaer County Department of Probation ("Department") is in need of two (2) additional handheld radios to enhance officer safety and to be used while conducting supervision, surveillance, and warrant execution on offenders that are being supervised by the Department's domestic violence unit; and

WHEREAS, The Department received a quote from Motorola Solutions for two (2) APX NEXT Single Band Portable Radios in the amount of \$16,905.56, via New York State Contract #PT68722, Award #23141, Group #77200; and

WHEREAS, Resolution G/197/26 authorized the acceptance of a grant award in the amount of \$193,240.00 from the New York State Division of Criminal Justice Services ("DCJS") for the Statewide Targeted Reductions in Intimate Partner Violence (STRIVE) Initiative for the prevention of and intervention (e.g., enforcement, prosecution) in incidences of intimate partner violence through evidence-based, survivor-centered, trauma-informed, and culturally responsive strategies; and

WHEREAS, The Department will utilize the DCJS STRIVE grant funding for this purchase with the funds being available within the Department's 2026 operating budget via appropriations code A.3140.02400.STRIVE.2026.02400; and

WHEREAS, This purchase is being made in accordance with the policies and procedures set for in the Rensselaer County Purchasing Guidelines; and

WHEREAS, The name and address of the vendor, the source of funding for this purchase, and the total amount to be expended for this purchase, which shall not exceed budgeted appropriations are as follows:

WHEREAS, This Resolution is filed with the Rensselaer County Legislature by the Rensselaer County Executive; and

WHEREAS, The New York State Office of Children and Family Services (OCFS) mandates the local social services districts to provide preventive services; and

WHEREAS, The Federal Administration for Children and Families approved New York State's Family First Prevention Services Act Prevention Plan which includes keeping children with kin and in family-based settings, the least restrictive environment for their needs and allows for the investment in more preventative, evidence-based programs; and

WHEREAS, Effective December 29, 2022, New York State raised the minimum age of juvenile delinquency jurisdiction from seven to twelve years of age and require that young people receive support services and help from differential response programs to prevent future interactions with the justice system; and

WHEREAS, The Rensselaer County Department of Social Services ("Department") developed a differential response plan which included a description of the type of assessments to be utilized to determine whether services are necessary, a description of services and supports to be provided to reduce the likelihood of children having contact with the juvenile justice and child welfare systems in the future and the process to be followed for planning and monitoring the services offered; and

WHEREAS, Based on the success of this program, the Department wishes to continue the partnership agreements between START Children's Center, Inc. ("START") Rensselaer County, Hoosick Falls Central District/Hoosick Valley Central School District and Brunswick-Brittonkill Central School District/Averill Park Central School; and

WHEREAS, START has a full-time Family Intervention Specialist directly in each of the two school's clusters, to reduce child welfare system involvement recidivism, provide support to families, provide service linkage to families and increase the youth's school engagement; and

RESOLUTION RECOGNIZING AUGUST 31, 2026 AS INTERNATIONAL OVERDOSE AWARENESS DAY

WHEREAS, International Overdose Awareness Day (IOAD) is observed globally on August 31st each year to raise awareness about overdose deaths and to emphasize that drug overdoses are preventable; and

WHEREAS, The annual event is the world's largest campaign to end overdose, reduce the stigma of drug-related deaths, and acknowledge the grief felt by families and friends. It seeks to highlight that overdose is preventable and advocate for evidence-based prevention strategies; and

WHEREAS, This year, 2026, marks the campaigns 25th anniversary with the official theme: "25 years on. Still needed"; and

WHEREAS, An overdose can happen when the body is overwhelmed by a toxic amount of substance or combination of substances. It's possible to overdose on many substances if they are abused, including alcohol, illicit drugs, and even prescribed medication; and

WHEREAS, When taking medication prescribed by your doctor it is important to know the right amount and the right time to take your medication. It is also vital to know what drugs should not be mixed, and to seek help if you feel you are not in control of your drug use; and

WHEREAS, For every drug overdose that results in death, there are many more non-fatal overdoses, each taking an emotional and economic toll on the individual, their family, and the community at large; and

WHEREAS, Overdoses can occur in people who have an addiction to substances as well as those who do not, such as someone accidentally overdosing on prescription opioids after a surgery or an injury, an elderly person consuming too much of a prescribed pain reliever, a teenager experimenting with illegal drugs for the first time or a child ingesting opioid pills or powders from a home medicine cabinet or other storage location; and

WHEREAS, Residents can help prevent overdose deaths by being aware of the signs and knowing how to respond to an overdose. Rensselaer County has taken great measures to educate the public, make Naloxone (Narcan) available for county residents, as well as participate in collaborative efforts resulting in permanent prescription drop box locations and continued drug take back days so residents can dispose of unused medicines and prescription drugs; and

WHEREAS, Our dedicated community members in collaboration with treatment providers work tirelessly to help individuals with substance use disorders recover; and

WHEREAS, Rensselaer County encourages communities to continue to develop and support local coalitions because this epidemic looks different in various parts of the county, and local engagement and leadership is imperative. Rensselaer County gives special recognition to our area volunteer and professional organizations and government agencies involved in the fight against substance use disorders and overdose awareness; and

WHEREAS, The Rensselaer County Legislature remains committed to raising awareness in order to combat the stigma associated with substance use disorders; now, therefore, be it

WHEREAS, This Resolution is filed with the Rensselaer County Legislature by the Rensselaer County Executive; and

WHEREAS, The Bureau of Public Safety seeks to enter into an intermunicipal agreement with the Town of Sand Lake and Sand Lake Ambulance, Inc. for Sand Lake Ambulance, Inc. to conduct a feasibility study regarding the potential merger of Sand Lake Ambulance, Inc. and North Greenbush Ambulance; and
