

WHEREAS, This Resolution is filed with the Rensselaer County Legislature by the Rensselaer County Executive; and

WHEREAS, As part of the 2011 Rensselaer County Jail Expansion Project, the Rensselaer County Sheriff's Office purchased a fingerprinting system used by the Rensselaer County Correctional Facility ("Jail") and Highway Patrol to meet the needs of an expanding modern jail; and

WHEREAS, The Sheriff's Office uses this system for digital fingerprinting of inmates in the Jail and arrest bookings in Highway Patrol, and for related reports needed for submission to the Department of Criminal Justice Services; and

WHEREAS, The system equipment and software provides vital interfacing with Black Creek, but does not allow for the latest and most secure software to be used, and has become obsolete with limited network support; and

WHEREAS, The Sheriff's Office is seeking to purchase two (2) Idemia New York RIC/CAPS TPE LiveScan Systems; one for the Jail and one for Highway Patrol, including hardware, software, installation, training and warranty; and

WHEREAS, The Idemia LiveScan system is a powerful biometric information acquisition and identification system used to capture demographic data, fingerprints, palm prints, mug shots, signatures and scars, marks and tattoos; and

WHEREAS, The purchase and installation of the fingerprinting system upgrade will be through New York State contract number PT68809 through Idemia Identity & Security USA LLC, 296 Concord Road, Suite 300, Billerica, MA 01821; and

WHEREAS, By Resolution No. G/319/17, the Rensselaer County Legislature declared that it was in the best interests of Rensselaer County and its residents to commence litigation against opioid supply chain participants to seek reimbursement to the County for its expenses resulting from the opioid epidemic; and

WHEREAS, By Local Law No. 3 of the year 2018, in support of the litigation against opioid supply chain participants, the Rensselaer County Legislature found and declared the opioid epidemic and its effects on the County a public nuisance; and

WHEREAS, In furtherance of Resolution No. G/319/17 and Local Law No. 3 of the year 2018, Rensselaer County is a party in pending consolidated litigation regarding the opioid addiction crisis, in which the State of New York, Nassau County, Suffolk County, and Rensselaer County, among other political subdivisions, are named as plaintiffs (the "Action"); and

WHEREAS, The Action is against several defendants, including manufacturers of opioids, distributors of opioids and chain pharmacies; and

WHEREAS, The Action alleges several causes of action against defendants Johnson & Johnson, Janssen Pharmaceuticals, Inc., Ortho-McNeil-Janssen Pharmaceuticals, Inc. and Janssen Pharmaceutica, Inc. ("J & J") based on claims that J & J contributed to the opioid epidemic by falsely promoting prescription opioids it manufactured and sold and by falsely promoting the increased use of opioids directly and generally through various "front groups" and failing to implement measures to prevent diversion of prescription opioids in connection with distribution of its products, all of which contributed to a public health crisis; and

WHEREAS, J & J has offered to settle the claims of public Nuisance against it by paying Rensselaer County a sum of no less than \$316,654.07 over ten (10) years to be used for restitution and abatement and agreeing to not manufacture, sell or promote opioids; and

WHEREAS, Rensselaer County has been advised by its litigation counsel to approve a settlement agreement and release ("J&J Agreement") in addition to an opioid settlement sharing agreement with New York State and its political subdivisions who join as a party to such agreement ("Sharing Agreement"); and

RESOLUTION HONORING THE VAN NEDERYNEN FARM FOR BECOMING A CENTURY FARM AND COMMENDING THE FAMILY FOR THEIR CONTRIBUTIONS TO RENSSELAER COUNTY

WHEREAS, A great County is only as great as those persons who give commendable service to their community, whether through participation in voluntary programs, through distinctive personal achievement in their professional or other endeavors or simply through a lifetime of good citizenry; and

WHEREAS, Such service, which is truly the lifeblood of the community and the County, so often goes unrecognized and unrewarded; and

The Van Nederynens is such a family, worthy of the esteem of their community as well as the County of Rensselaer; and

Gerrit Van Nederijnen was born in 1860 and Maria van Kampen in 1862. They were married on May 4, 1889 at Hilversum in the Holland province of the Netherlands and had four children; and

WHEREAS, Believing his Royal Netherlands Marines pension would go farther in the United States, Gerrit and his family immigrated to the United States in 1907 on the Nieuw Amsterdam; and

WHEREAS, After being processed through Ellis Island in New York they headed to Castleton-on-Hudson where there was a significant population of Dutch immigrants in the early 1900s; and

WHEREAS, During WWI, two of Gerrit and Maria's sons, Albert and Fred, served in the US Army in France where Albert saw combat as a forward artillery observer and becoming a member of the American Legion Post in Castleton when he returned home; and

WHEREAS, Hearing that farm life was recuperative for men exposed to gas warfare in France, Gerrit and Maria purchased property from Christian Braum and his wife on March 30, 1921 and moved their family from Castleton to the farm on The Castleton Road, now Maple Hill Road; and

On February 27, 1926 Albert married Hendrika Lievestro whom he had met in Castleton but whose family had also immigrated from the Holland region of the Netherlands; and

WHEREAS, On April 1, 1926, Gerrit and Maria transferred ownership of the hay farm to Albert; and

WHEREAS, Albert considered the economics and determined that egg production took the least capital and resulted in the quickest and most significant income; and

WHEREAS, In those early years as the egg farm was getting established Albert sold a number of agricultural products. He began building the farm by construction of the corn crib, and the front hen house; and

WHEREAS, Albert and Rika had 3 children, their youngest, Albert Lievestro (simply known as Al), was born on August 12, 1929; and

WHEREAS, In May 1940, with family and friends in the Netherlands, they were keenly aware of Nazi Germany's invasion of the low countries in 1940 and for the brief period before the United States entered World War 2, they transcribed coded messages between people in the Netherlands and those in the former Dutch colonies. During World War II, Albert continued egg production while participating as an aircraft spotter in Rensselaer County; and

WHEREAS, After the war, he continued operating the egg farm along with several civic pursuits Focused on Public Health, Veterans Services, and Agriculture; and

WHEREAS, Albert's youngest son Al married Dorothy (Dot) Miaski and built a house for them alongside the 3 story old barn on the farm; and

WHEREAS, Throughout the 1950s, as Albert was working to support veterans, AL took on expanding the Fair-Dale farm and their family and the hen house for egg layers quadrupled in size; and

WHEREAS, During the Korean War, Al's egg farm was classified as an essential business by the US government; and

WHEREAS, In the 1950's and early 1960's AL was active in the New York Cooperative Extension Service and Farm Bureau as they were consolidating and restructuring for the changing times; and

WHEREAS, Al was one of the first school bus drivers before the Castleton, Brookview and Schodack country schools were consolidated into the Schodack Central School District. Al also employed local kids and, in a unique arrangement, coordinated with the school so after the needed classwork was done in the morning, some students could work on the farm and get practical job experience. Today that would be called a Work-Study program; and

WHEREAS, After making the difficult decision to shut down the egg farm. All worked numerous jobs to pay off the farms debts. Building homes suited AL and in 1973 he built his first Cedar Log Home. 27 years later, All was still building Cedar Log Homes. Through his work he gave many people their first jobs, mentoring them as they entered the adult working world. Some have gone on and are in the construction and renovation industry today; and

WHEREAS, Where Albert Van Nederynen's life was focused on Public and Veterans services. Al's has been focused on the youth of our community.

WHEREAS, Al's youngest son Scott married Paula Chandler on the farm and purchased the brick house on the farm that his Grandfather Albert had built in 1959; and

WHEREAS, The farm has gone from being a subsistence farm to an egg farm and today is growing premium Christmas Trees; now, therefore, be it
