SECTION 1: TITLE

This Local Law shall be known as "The Rensselaer County Solar Panel Recycling Law".

SECTION 2: PURPOSE AND INTENT

The use of solar panels is increasing. The typical service life of a photovoltaic panel is 25-30 years, and many early adopters of solar power now have panels at or nearing the end of their lifespan, and it is expected solar panel waste will increase drastically in the coming years. Waste created from photovoltaic panels presents a threat to the environment, as they include heavy metals that have the potential to contaminate groundwater if placed in landfills. Panels also contain rare earth materials and valuable materials, which should be utilized beyond the life of the solar panel.

In order to preserve the environment, protect human health, and utilize resources most prudently, solar panels should be collected and disposed of in a manner that reduces the environmental impacts, and capitalizes on the reuse of rare and valuable metals. Establishing a solar panel collection program among manufacturers of solar panels will provide an alternative disposal method, and promote the recycling of solar panels.

As residents of New York State switch to alternative forms of energy in order to reduce dependence on fossil fuels, we have seen a rise in the use of solar panels. The immense growth of the solar energy industry could lead to an accumulation of photovoltaic (PV) waste. The U.S Department of Energy projects the nation will have cumulatively installed 700 gigawatts of PV equipment.

Eventually, all of this equipment will reach the end of their life and become PV waste. These PV modules contain various valuable materials and rare metals, proper recycling will ensure that these materials and metals are able to be reused. By recycling solar panels, we can ensure that solar panels do not prematurely arrive at landfills where they can have potential negative environmental effects. It is essential that we take action that is both economically and environmentally friendly. In order to do this we must establish infrastructure to accommodate for the long-term management of solar waste.

SECTION 3: DEFINITIONS

- 3.1 "Collection program" means a system, established, maintained, and funded by solar panel manufactures, in which out-of-service solar panels are collected and recycled.
- 3.2 "Recycling" means reprocessing solar panels in order to recover materials for re-use and/or repurpose.
- 3.3 "Repurpose" means utilizing materials taken from the solar panel recycling process and implementing them for a use other than the original use.
- 3.4 "Re-use" means utilizing materials taken from the solar panel recycling process and continuing the original use.
- 3.5 "Manufacturer" is a person or other entity that manufactures solar panels.
- 3.6 "Retailer" is a person or other entity that sells solar panels to individuals or other consumers, through sales and distribution methods including the use of online or distance sales.
- 3.7 "Consumer" means an individual, business, municipality, or other entity that purchases one or more solar panels.
- 3.8 "Solar panel" means an instrument that uses a bank of solar cells to generate electricity or heat, from solar radiation.
- 3.9 "Out-of-service solar panel" means any solar panels that is no longer in working order or is removed, replaced, or otherwise removed from service.

SECTION 4: SOLAR PANEL COLLECTION PROGRAM REQUIREMENTS

4.1 Any manufacturer, alone or in coordination with other manufacturers, must establish and maintain a collection program that provides for the disposal of out-of-service solar panels at no cost to the party disposing of the solar panel(s). This collection program must

properly repurpose and reuse the appropriate materials, such as rare earth materials and commercially valuable metals, and dispose of panels in a manner that does not jeopardize the environment or groundwater quality.

- 4.2 No manufacturer may sell, or propose for sale, solar panels in the County unless participating in an established solar panel collection program.
- 4.3 The collection programs are to be maintained financially by the solar panel manufacturers, alone or in coordination with other manufacturers.
- 4.4 The manufacturers must also create and maintain a web page which provides the public with information regarding where and how to dispose of solar panels in the collection program, and other education materials about the importance of proper solar panel disposal.
- 4.5 Solar panel manufacturers will be required to provide to the County a report of the number of solar panels collected, and the web-based information they have provided the public.
- 4.6 No transfer station or landfill shall knowingly allow solar panels to be placed in a landfill or incinerator. Landfills and transfer stations must decline solar panels, and provide notice to the public, in the form of signage and statements on webpages, that solar panels will not be accepted.
- 4.7 Any consumer or contractor replacing or removing solar panels, or destructing a structure upon which solar panels are placed, must ensure out-of-service solar panels are transported to a collection site.

SECTION 5: ENFORCEMENT

- 5.1 The County Department of Health is hereby granted and shall have the authority to enforce this Local Law on behalf of the County. The County Department of Health may coordinate enforcement with the County Department of Consumer Affairs.
- 5.2 Upon a violation of this Local Law the County is hereby authorized to enforce this Local Law by exercise of any one or more of its powers granted to it under the New York State Public Health Law and regulations thereunder, including, without limitation, imposition of a civil penalty not to exceed two thousand dollars (\$2,000) upon a person for any and each and every violation of, or failure to comply with, any provision of this Local Law.

5.2 The Department of Health may establish administrative procedures for implementing Section 5 of this Local Law.

SECTION 6: ADDITIONAL PROVISIONS

- 6.1 In adopting and implementing this Local Law, the County assumes an undertaking only to promote the general welfare. The County does not assume or impose upon its officials and employees an obligation by which any one or more of them could be liable in money damages to any person or entity who claims that a breach proximately caused injury.
- 6.2 This Local Law shall be construed so as not to conflict with applicable federal or state laws, rules or regulations. Nothing in this Local Law shall authorize any County bureau or department to impose any duties or obligations in conflict with limitations on municipal authority established by state or federal law at the time such bureau or department action is taken. The County shall suspend enforcement of this Local Law to the extent that said enforcement would conflict with any preemptive state or federal legislation subsequently adopted.
- 6.3 Nothing in this Local Law is intended to protect anticompetitive or collusive conduct nor shall this Local Law be construed to modify, impair, or supersede the operation of any antitrust law or unfair competition law of the State of New York or the United States.
- 6.4 This Local Law shall be null and void on the date that statewide or federal legislation goes into effect, incorporating either the same or substantially similar provisions as are contained in this Local Law, or in the event that a pertinent state or federal administrative agency issues and promulgates regulations preempting such action by the County. The County Legislature may determine by resolution whether or not identical or substantially similar statewide legislation has been enacted for the purposes of triggering the provisions of this Section 6.5.
- 6.5 If any clause, sentence, paragraph, subdivision, section, or part of this Local Law or the application thereof to any person, individual, corporation, firm, partnership, or business shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof but shall be confined in its operation to the clause, sentence, paragraph, subdivision, section, or part of this law, or in its specific application.

SECTION 7: EFFECTIVE DATE

This Local Law shall become effective as provided in Municipal Home Rule Law §27.

WHEREAS, Rensselaer County (the "County") issued a Request for Proposals (RFP-13-37) for a performance-based energy savings and operations plan for various county facilities; and

WHEREAS, Based on the evaluation of the proposals, Siemens Industry, Inc. ("Siemens") was selected to develop and implement a performance-based energy savings and operations plan; and

WHEREAS, Siemens has provided the County with Facility Improvement Measures Report for the Rensselaer County Cornell or Agriculture and Life Sciences Building dated August 15, 2022 (the "Agriculture Building Report") which sets forth detailed plans for improvements of the Agriculture and Life Sciences Building, including LED lighting upgrade with fixture replacement, lighting controls - enlighted IoT, install new AHU/VRF for conference room, needlepoint bipolar ionization, Card Access, Security, closed circuit TV and fire alarm, new generator installation, new windows installation, HVAC commissioning, testing and balancing, and renovation of floors; now, therefore, be it

RESOLVED, By the County Legislature of Rensselaer County, New York, as follows:

Section 1. In accordance with Section 9-103 of the Act, the County is hereby authorized to enter into one or more energy performance contracts with Siemens, and related lease/purchase agreements and other agreements with Siemens Public, Inc. (collectively the "Agreements"), in an aggregate original principal amount not to exceed \$9,773,357.00, plus performance program payments not to exceed \$1,827.00 annually, with respect to the work related to the Agriculture Building Report, pursuant to which Siemens provide equipment, capital improvements, repairs, preventative maintenance and other services to improve the efficiency of Rensselaer County Agriculture and Life the Sciences Building, as more particularly described in the Agriculture Building Report and to pay reasonable costs of issuance relating to the Agreements.

Section 2. The Chief Fiscal Officer, as Chief Fiscal Officer of the County, is hereby authorized to negotiate and deliver on behalf of the County the Agreements and all other certificates or instruments required in connection therewith provided, however, that all amounts payable by the County pursuant to the Agreements shall be subject to annual appropriation of such payments by the County Legislature. The power to prescribe the terms, forms and covenants of the Agreements is hereby delegated to the Chief Fiscal Officer, as Chief Fiscal Officer, subject to the approval as to form of the County Attorney.

Section 3. This Resolution is intended to constitute the declaration of the County's "official intent" to reimburse the costs of the improvements described in Section 1 of this resolution with proceeds from the Agreements with Siemens, as required by Treasury Regulation Section 1.150-2.

Section 4. This Resolution is not subject to a mandatory or permissive referendum.

Section 5. The County hereby determines that the provisions of the State Environmental Quality Review Act and the regulations thereunder have previously been satisfied with respect to the expenditures authorized by this Resolution.

Section 6. All acts previously taken by the County with respect to the execution and delivery of the Agreements are hereby further authorized, with the assistance of, and subject to the approval of, the County Attorney, ratified and confirmed.

WHEREAS, During construction, a local farmer saw the blocks and asked if he could buy some for his barn. This is how Salvatore Zappala began manufacturing and selling concrete building blocks; and

WHEREAS, Soon the house was completed and Salvatore's wife Giovanna and their children Nancy and Vincent joined him in America. Their children Sadie and Phyllis were born here; and

WHEREAS, Salvatore set up a plant alongside his home and continued to manufacture concrete blocks by hand. As new equipment evolved, so did Salvatore. From a one-at-a-time hand machine to a three-at-a-time automatic machine, he was always at the forefront of new technology and equipment; and

WHEREAS, Eventually, in 1940, Salvatore was able to purchase a parcel of land and build a new block plant along the Hudson River in Rensselaer, New York; and

WHEREAS, Consistent with the duty of this Legislative Body to acknowledge those individuals and institutions who have contributed to the vitality of Rensselaer County, we recognize with profound respect and admiration an important milestone in the history of the community; and

WHEREAS, Attendant to such duty and fully in accord with its longstanding traditions, it is the intent of this Legislative Body to convey its compliments and felicitations to the Hart Cluett Museum (HCM) on the occasion of its ninety-fifth anniversary; and

WHEREAS, Established in 1927 as the Rensselaer County Historical Society (RCHS) to connect local history and heritage with contemporary life, the HCM enriches the present and advocates for the future by bringing the region's past to life, recognizing every face and every story. In pursuit of this mission, they collect, preserve, study, interpret, and make accessible a broad variety of objects and documents. They also conduct educational programs that inspire public enthusiasm for our roots and bolster the entrepreneurial appetites of our community; and

WHEREAS, In 1948, Albert E. Cluett and his wife, Caroline Ide Cluett, challenged RCHS to raise sufficient funds to support the operation of their Troy townhouse as a museum. They were successful, and in 1952, the building, which was formerly owned and lived in by the Hart family, was turned over to RCHS by Caroline Cluett. RCHS had a building with great potential as a historic house museum and repository for the county's historical artifacts and archival materials; and

WHEREAS, In 1957, H. Maxson Holloway was hired as the first director of RCHS. Holloway's immediate plans included the careful acquisition of fine and decorative arts as well as period furnishings to fill the fourteen rooms of the house. The process of raising money and acquiring objects continued for over a decade; and

WHEREAS, It became clear by the mid-1970s that RCHS had outgrown the Hart-Cluett House and Carriage House. Growth of the collections and demands for programs had outpaced the building's space. In 1976, the Carr building to the north of the Museum was acquired, and it became an educational and administrative center. The project was finished in 1982, providing a meeting room, gift shop and exhibition gallery on the first floor of the Carr Building; and

WHEREAS, As historic preservation became an issue in the community and the nation in the 1970s, RCHS took an active position in favor of preserving the built environment. There were many battles to fight as the pressures of suburbanization, the loss of Troy's heavy industry and beginnings of urban renewal programs became a part of daily life. In part due to the efforts of RCHS, much of the historic architecture in Troy was preserved, and this now beloved architecture is a significant draw for visitors and filmmakers, resulting in a major boost for the local economy; and

WHEREAS, In 2019, RCHS was renamed the Hart Cluett Museum, after the previous dwellers of the building in which it is housed; and

WHEREAS, Today, HCM offers many house tours and walking tours of Troy, while continuing to display exhibits and learn more about the history of Rensselaer County and its people; now, therefore, be it
