Section 1. Legislative Intent

The purpose and intent of this local law is to adopt and make effective in Rensselaer County Section 459-c of the Real Property Tax Law of the State of New York, as in effect on the date this local law takes effect, and as such section may be subsequently amended, applicable to the County of Rensselaer County Taxes for qualifying property owners.

Section 2. Applicability

There shall be an exemption from taxation for general county purposes for certain individuals with disabilities in accordance with Section 459-c of the Real Property Tax Law and this local law.

Section 3. Income Levels

The income level for receipt of a partial exemption from real property taxation for the purposes of taxes levied by the County of Rensselaer, pursuant to Section 459-c of the Real Property Tax Law, is as follows:

Section 4. Limitation

No exemption shall be granted if the income of the owner or the combined income of the owners of the subject property for the applicable income tax year equals or exceeds \$50,400.00.

Section 5. Exclusions, Inclusions and Offsets

Distributions received from an individual retirement account or individual retirement annuity that were included in the applicant's federal adjusted gross income shall not be considered income. Any social security benefits that were not included in the applicant's federal adjusted gross income shall be considered income. The applicant's income shall not be offset by any medical and prescription drug expenses actually paid that were not reimbursed or paid for by insurance.

Section 6. Incorporation Provision

All other provisions of Section 459-c of the Real Property Tax Law, to the extent not inconsistent with this local law, shall be in effect for the purpose of County real property taxation in the County of Rensselaer.

Section 7. Conflicts Provision

In the event of a conflict or inconsistency between this local law and any previous local law of the County of Rensselaer, the terms of this local law shall govern and the conflicting or inconsistent terms of the previous local law(s) are hereby amended to be null and void.

Section 8. Effective Date

This local law shall take effect upon the filing with the Office of the Secretary of State of the State of New York and shall apply to assessment rolls based upon a taxable status date occurring on or after January 1, 2026.

The purpose and intent of this local law is to adopt and make effective in Rensselaer County Section 467 of the Real Property Tax Law of the State of New York, as in effect on the date this local law takes effect, and as such section may be subsequently amended, applicable to the County of Rensselaer County Taxes for qualifying property owners.

Section 2. Applicability

There shall be an exemption from taxation for general county purposes for certain individuals 65 years of age or over in accordance with Section 467 of the Real Property Tax Law and this local law.

Section 3. Income Levels

The income level for receipt of a partial exemption from real property taxation for the purposes of taxes levied by the County of Rensselaer, pursuant to Section 467 of the Real Property Tax Law, is as follows:

Any social security benefits that were not included in the applicant's federal adjusted gross income shall be considered income. The applicant's income shall not be offset by any medical and prescription drug expenses actually paid that were not reimbursed or paid for by insurance.

Section 6. Incorporation Provision

All other provisions of Section 467 of the Real Property Tax Law, to the extent not inconsistent with this local law, shall be in effect for the purpose of County real property taxation in the County of Rensselaer.

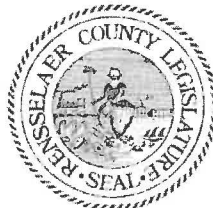

RESOLUTION RECOGNIZING OCTOBER AS NATIONAL BREAST CANCER AWARENESS MONTH IN RENSSELAER COUNTY

WHEREAS, National Breast Cancer Awareness Month was founded in 1985 in partnership between the American Cancer Society and the pharmaceutical division of Imperial Chemical Industries, a producer of several anti-breast cancer drugs; and

WHEREAS, The aim of the NBCAM from the start has been to promote mammography as the most effective weapon in the fight against breast cancer; and

WHEREAS, In 1993 Evelyn Lauder, Senior Corporate Vice President of the Estée Lauder Companies, founded the Breast Cancer Research Foundation and established the pink ribbon as its symbol. In the fall of 1991, the Susan G. Komen Foundation handed out pink ribbons to participants in its New York City race for breast cancer survivors; and

WHEREAS, Breast Cancer Awareness Month is celebrated in October and this year's theme is "Think Before You Pink". It is a campaign launched by Breast Cancer Action to raise awareness of pinkwashing and to help people donate in the most effective way to the cause. The campaign aims to raise awareness of the signs and symptoms of breast cancer, tackle barriers to early detection and diagnosis and addresses inequalities in access to information and support; and

WHEREAS, Breast Cancer Awareness Month can mean different things to different people. For some, it's a trigger – 31 days in the fall of pink-ribbon reminders of a disease that forever changed them while for others, it's a chance to show their support for the more than 2 million women around the world who are diagnosed with the disease each year; and

WHEREAS, Breast cancer is the most common cancer diagnosed among woman in the United States. It is the second leading cause of death from cancer among woman; and

WHEREAS, A new American Cancer Society (ACS) report finds that the incidence of breast cancer in women has continued to increase, rising by 1% a year. These cases are largely confined to localized-stage cancers, which have not spread from the breast, and hormone receptor-positive disease (either estrogen positive or progesterone positive), the most common type of breast cancer; and

WHEREAS, In contrast to rising incidence, the death rate for breast cancer among women in the United States has dropped 44% from its peak in 1989. The continuous decline in breast cancer death rates is attributed to advances in treatment and early detection; and

WHEREAS, The chance of developing invasive breast cancer at some time in a woman's life is about 1 in 8 and increases by 24% with age; and

WHEREAS, Certain factors may put you at higher risk for developing breast cancer. These include a woman's age and genetic makeup as well as family history and personal health history such as diet or exercise habits; and

WHEREAS, National Breast Cancer Awareness Month remains dedicated to promoting and spreading awareness about the importance of early detection and the key role it plays in the advanced treatment of breast cancer; and

WHEREAS, The American Cancer Society has searched endlessly for a cure through vital research and has the mammoth task of educating our community and all Americans of the risks of breast cancer. Its many volunteers offer support in the form of support groups, accommodations and transportation assistance, medical equipment and more; now, therefore, be it

WHEREAS, Since World War I, the observance has provided a way to recognize and honor those who have lost a family member who served our country in the United States Armed Forces; and

WHEREAS, Service flags have a deep Blue Star for each living member in the service and a Gold Star for each member who has died, thus the Gold Star and the term Gold Star Mother was applied to all mothers who lost a son or daughter during World War I; and

WHEREAS, In 2011, President Barack Obama amended the day to "Gold Star Mother's and Family Day"; now, therefore, be it

WHEREAS, National POW/MIA Recognition Day is an annual observance in the United States dedicated to honoring and remembering the sacrifices of American service members who were prisoners of war (POWs) and those who are still missing in action (MIA); and

WHEREAS, National POW/MIA Recognition Day was first observed in 1979 after Congress and then President Jimmy Carter signed a proclamation making it official, after the families of the more than 2,500 Vietnam War POW/MIAs pushed for full accountability in finding their loved ones; and

WHEREAS, Since 1979, National POW/MIA Recognition Day has been held on various dates. In 1986 it was established as the third Friday in September, a date recognized throughout the nation and around the world on military installations, ships at sea, state capitols, schools, churches, national veteran and civic organizations, police and fire departments, etc. and is one of the six days specified by law on which the black POW/MIA flag shall be flown over federal facilities, cemeteries, post offices and military installations; and

WHEREAS, Roughly 81,600 service members remain missing in action. This number includes personnel from World War II, the Korean War, the Vietnam War, the Cold War, and other conflicts; and

WHEREAS, The Defense Department remembers and honors those Americans who were prisoners of war and those who served and never returned home. The Department of Defense's POW/MIA Accounting Agency continues the search for the missing, fulfilling the nation's promise to leave no service member behind; and

WHEREAS, America has been blessed by the brave men and women of our Armed Forces who have answered the call of duty to defend our Country and protect liberty around the world. On National POW/MIA Recognition Day, we honor a special group of patriots: those who have been prisoners of war and those who are still missing in action. We remain forever in their debt, and we renew our commitment to them and to their families never to rest until we have accounted for every missing service member; and

WHEREAS, These individuals, along with their families, are to be honored and respected for their past and continuing sacrifices; now, therefore, be it

RESOLUTION RECOGNIZING OCTOBER AS NATIONAL RETT SYNDROME AWARENESS MONTH IN RENSSELAER COUNTY

WHEREAS, National Rett Syndrome Awareness Month is observed every October. This month is dedicated to raising awareness about Rett syndrome, a rare genetic neurological disorder that affects girls 1 in 10,000 females and is more rarely seen in males; and

WHEREAS, The clinical features of Rett Syndrome were first described in 1966 by Dr. Andreas Rett and named for him in 1983; and

WHEREAS, Symptoms usually begin to display themselves between the ages of 6 to 18 months in missed milestones or regressions and leads to severe impairments affecting nearly every aspect of life: ability to speak, walk, eat and breathe easily; and

WHEREAS, Delayed growth becomes noticeable and problems arise with crawling or waking, control of hands, communication skills and eye contact; and

WHEREAS, As the disease progresses, children can also develop unusual hand movements, breathing problems, irritability and even seizures; and

WHEREAS, Cognitive assessment in children with Rett Syndrome is complicated but we know that they understand far more than they can communicate evidenced by their bright and attentive eyes and their ability to express a wide spectrum of moods and emotions; and

WHEREAS, In nearly all cases, the genetic change that causes Rett syndrome is spontaneous, meaning it happens randomly. Such random mutations are usually not inherited or passed from one generation to the next. However, in a very small percentage of families, Rett mutations are inherited and passed on by female carriers. Among families with a child affected by Rett syndrome the chance of having a second child with the syndrome is very low; and

WHEREAS, Although a cure for Rett Syndrome has not yet been found, scientists have identified the cause as a genetic disorder that comes from mutations of the X Chromosomes. It can be treated with medication while occupational therapy; physiotherapy and hydrotherapy can improve a child's mobility; and

HEREAS, During National Rett Syndrome Awareness Month a campaign is conducted to promote greater awareness of this disorder and the need for more clinical research that will help improve the lives of children affected by Rett Syndrome, now, therefore, be it

WHEREAS, It encourages a shift from a culture of silence and stigma to one of openness, understanding, and support. WHEREAS, The goal is to create environments where individuals feel safe and empowered to seek help and engage in meaningful conversations about their struggles; and

WHEREAS, Rensselaer County has a Suicide Prevention Task Force, facilitated by the Commissioner of Mental Health in collaboration with AFSP, SPCNY (Suicide prevention Center of NY); Veterans, survivors, school districts, local hospital, county Health Departments and interested community members, which is focused on the need to change the narrative via evidence-based gatekeeper trainings throughout the community; reduction of lethal means; postvention training; and evidence-based screening, assessment and treatment for those with suicide ideation; now, therefore, be it

WHEREAS, The Distinguished Alumnus Award was established in 1994 at the direction of Brother James L. Romond, then principal of La Salle Institute. This award is a high honor bestowed by the Alumni Association to an alumnus who has had a distinguished career and has made a great impact on their community. A Distinguished Alumnus demonstrates the mission of La Salle Institute and reflects the ideals of truth, honor, and duty; and

WHEREAS, General Stephen Lyons was commissioned a Second Lieutenant in the US Army upon graduation from Rochester Institute of Technology in 1983. He began his career in Germany during the Cold War and subsequently held a wide range of leadership assignments that included command of troops at every level, including multiple combat deployments (Panama, Bosnia-Herzegovina, Iraq, Afghanistan). As a battalion commander in 2003, he led more than 1,200 Soldiers as part of the 3rd Infantry Division ground assault to liberate Baghdad. He subsequently spent more than 40 months deployed to the US Central Command area of responsibility in support of Operation Iraqi Freedom and Operation Enduring Freedom, Afghanistan. He has over 9 years of experience in joint assignments; and

WHEREAS, General Lyons' flag officer assignments include Afghanistan International Security Assistance Force (ISAF) C/J-4 (2009-2011), Headquarters Department of the Army Staff, Commander 8th Theater Sustainment Command (Indo-Pacific), Commander US Army Combined Arms Sustainment Command, Deputy Commander TRANSCOM, and Joint Staff Director of Logistics (J4). As TRANSCOM commander, he oversaw the largest noncombatant evacuation airlift operation in US history, resulting in the successful evacuation of 124,000 Afghans within two weeks' time; and

WHEREAS, He holds two master's degrees, one from the Naval Postgraduate School in Logistics Management, and the second from the Industrial College of the Armed Forces in National Resource Strategy; and

WHEREAS, General Lyons' awards include the Defense Distinguished Service Medal, Bronze Star, and the Master Parachutist Badge. He is the recipient of the National Defense Transportation Association 2021 distinguished leader award and has been inducted into the Hall of Fame at the Naval Postgraduate School and the US Army Materiel Command; and

WHEREAS, General Steve Lyons retired from the US Army in 2021 after over 38 years of service, culminating as the 13th commander of US Transportation Command (TRANSCOM). TRANSCOM is one of 11 DOD combatant commands responsible for deploying and sustaining military forces globally, providing humanitarian assistance, and integrating the Department's multibillion-dollar joint deployment and distribution enterprise; and

WHEREAS, Upon retirement, he and Maureen, his wife of 32 years, settled in Davidson, North Carolina. He is currently a senior fellow for the Institute for Defense and Business at UNC Chapel Hill and senior mentor for the National Defense University Capstone, Keystone, and Pinnacle programs; now, therefore, be it
