RESOLUTION AMENDING THE 2026 RENSSELAER COUNTY ADOPTED BUDGET - DEPARTMENT OF HEALTH

WHEREAS, This Resolution is filed with the Rensselaer County Legislature by the Rensselaer County Executive; and

WHEREAS, Resolution G/369/24 authorized the acceptance of a grant award from the New York State Department of Health ("NYSDOH") for the Lead Rental Registry Program in the amount of \$3,636,000.00 for a five-year program period beginning April 1, 2024 through March 31, 2029; and

WHEREAS, The Rensselaer County Department of Health ("Department") has been awarded an additional \$35,775 annually for years 3-5 amending the total award to \$3,743,325.00, an award of \$762,975.00 for each of the remaining three years of the five-year program period, April 1, 2026 through March 31, 2029; and

WHEREAS, The funding is being used to establish a lead rental registry with the ability to identify applicable dwellings, collect statewide inspection and compliance data for communities of concern, provide flexibility to incorporate existing established programs and registries, and foster community partnerships and solutions; and

WHEREAS, This funding is being used in the identification and remediation of lead hazards in rental housing before children are harmed by lead poisoning; and

WHEREAS, The Department has set goals of requiring periodic inspections for lead hazards and providing an effective enforcement mechanism to ensure compliance; now, therefore, be it

RESOLVED, That any positions, programs, expenditures and/or agreements or contracts authorized or established pursuant to this resolution shall terminate and cease upon discontinuance of said funding; and, be it further

RESOLVED, That the 2026 Rensselaer County Adopted Budget shall be and is hereby amended as follows:

WHEREAS, This Resolution is filed with the Rensselaer County Legislature by the Rensselaer County Executive; and

WHEREAS, Resolution G/369/24 authorized the acceptance of a grant award from the New York State Department of Health ("NYSDOH") for the Lead Rental Registry Program for the period beginning April 1, 2024 through March 31, 2029; and

WHEREAS, The funding is being used to identify lead hazards, with goals of identifying high risk housing, providing resources to homeowners, and developing community partnerships to sustain the program past the life of the grant; and

WHEREAS, The Department will administer and oversee the grant activities by continuing to collaborate and contract with the City of Troy, 433 River Street, Suite 5001, Troy, NY 12180, to meet the goals and objectives of this program; and

WHEREAS, The Department seeks to enter into a contract with the City of Troy for the period of April 1, 2026 through March 31, 2029, with the intent that such contract would be amended on an annual basis through the end date of the noted grant with the amount of year 1 being \$433,294.00, and years 2 and 3 being said amount plus cost of living adjustments; and

WHEREAS, The Department will submit future required Resolutions to amend said contract for the additional cost of living adjustments as necessary; and

WHEREAS, This Resolution is filed with the Rensselaer County Legislature by the Rensselaer County Executive; and

WHEREAS, The Rensselaer County Department of Health ("Department") pursuant to Education Law Section 4410 and related New York State Early Intervention Regulations is required to provide transportation to authorized programs for children ages birth to five (5) years old with special needs; and

WHEREAS, The Department received quotes/proposal from various vendors via RFB-26-13 for transportation program clusters for the Division of Special Needs, with Rejha Group, LLC, 23 Railroad Avenue, Albany, New York 12205 providing the most advantageous bid; and

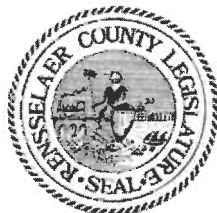

WHEREAS, In 2024 New York Attorney General Letitia James announced a settlement with JUUL Labs, Inc. for the Capital Region to combat youth vaping epidemic and as part of this settlement Rensselaer County Department of Health is being awarded a total of \$605,331.97 from 2025 to 2030; and

WHEREAS, The settlement amount is to be divided into eight equal payments of \$75,666.49 with the amount of \$226,999.49 received in 2025 being equal to three parts of this settlement; and

WHEREAS, The remainder of the settlement funds to be received in subsequent years 2026 through 2030 with the Department expected to receive the 2026 portion of \$75,666.50 this Spring; and

WHEREAS, The JUUL Labs, Inc. settlement funds are to be used for evidence-based measures to combat underage vaping and e-cigarette addiction with New York State requiring Counties to dedicate the settlement funds they receive into five categories: Public Education, Community anti-vaping programs, Vaping cessation, Enforcement of vaping laws, and Public Health Research; and

WHEREAS, Rensselaer County is committed to keeping harmful products out of the hands of children and minors, and ensuring their health, safety and quality of life; and

WHEREAS, The JUUL Labs, Inc. settlement marks a crucial step in the ongoing fight against youth vaping and will allow the Department to implement vital programs aimed at preventing underage vaping and supporting those affected; and

WHEREAS, The funds will enable the Department to begin educational campaigns, commence cessation services, and enforce vaping regulations that protect our youth from the harmful effects of e-cigarettes; and

WHEREAS, This Resolution is filed with the Rensselaer County Legislature by the Rensselaer County Executive; and

WHEREAS, The Rensselaer County Legislature previously authorized the acquisition of a Mobile Communications and Command Center (MCC) under Resolution G/454/25 to enhance countywide emergency response, coordination and interoperability capabilities; and

WHEREAS, The MCC is a 42-foot, tri-axle, fifth-wheel unit with an approximate gross vehicle weight of 24,000 pounds, requiring a properly rated and purpose-built towing vehicle to ensure safe, compliant and effective transport; and

WHEREAS, The F-450 platform provides the necessary towing capacity, stability, braking performance and fifth-wheel/gooseneck configuration required to transport the MCC while maintaining operational safety for personnel and the motoring public; and

RESOLUTION IN SUPPORT OF NEW YORK STATE SENATE BILL S.10037 AND ASSEMBLY BILL A.11242 TO RESTORE SAFE PUBLIC ACCESS TO RIVERFRONT PARK IN THE VILLAGE OF CASTLETON-ON-HUDSON

WHEREAS, The Village of Castleton-on-Hudson is situated directly along the Hudson River and has historically lacked meaningful public access to its waterfront due to the railroad corridor separating the community from the shoreline; and

WHEREAS, Riverfront Park in the Village of Castleton-on-Hudson represents the community's only potential public access point to the Hudson River waterfront; and

WHEREAS, Public access to Riverfront Park has remained closed since 1994 when the Village agreed to restrict public use of the existing at-grade pedestrian rail crossing in connection with plans related to high-speed rail improvements and based upon an understanding that New York State would provide an alternative means of public access; and

WHEREAS, While proposals for a grade-separated pedestrian bridge were explored, such proposals proved financially impractical for the Village due to the long-term maintenance costs and liability obligations associated with such infrastructure; and

WHEREAS, The continued lack of lawful public access has not only deprived residents and visitors of the opportunity to safely enjoy the Hudson River waterfront, but has also contributed to ongoing concerns regarding individuals attempting to illegally cross the railroad tracks, creating unacceptable public safety risks; and

WHEREAS, In 2023, the Rensselaer County Legislature adopted Resolution P/371/23 in support of the Village of Castleton-on-Hudson's petition to the New York State Department of Transportation seeking the removal of fencing at the Scott Avenue crossing to restore public access to the waterfront; and

WHEREAS, Although the Village's efforts through the administrative process did not ultimately result in reopening the crossing, the Village of Castleton-on-Hudson, in partnership with Scenic Hudson and state legislators, has continued pursuing a legislative solution to restore safe public access; and

WHEREAS, New York State Senate Bill S.10037 and Assembly Bill A.11242 would direct the New York State Department of Transportation to construct and install safety gates for the railroad crossing at Scott Avenue west of Main Street in the Village of Castleton-on-Hudson within two years of enactment; and

WHEREAS, This legislation represents a practical and commonsense solution that balances public safety with the longstanding goal of restoring waterfront access to the residents of Castleton-on-Hudson; and

WHEREAS, At a time when substantial public resources are being invested by federal, state, and local governments, as well as environmental organizations and taxpayers, into cleaning, preserving, and revitalizing the Hudson River, it is critical that the public also have safe and equitable access to enjoy and appreciate this invaluable natural resource; and

WHEREAS, Restoring safe access to Riverfront Park would promote recreation, tourism, environmental education, waterfront revitalization, and economic development opportunities within the Village and throughout the region; now, therefore, be it

RESOLUTION URGING NEW YORK STATE TO CONDUCT ADDITIONAL AIR TESTING IN THE CITY OF RENSSELAER AND TOWN OF EAST GREENBUSH AND TO FOLLOW THE PRINCIPLES OF THE 2024 HEALTH EQUITY PLAN

WHEREAS, The Rensselaer County Legislature recognizes its responsibility to protect the health, safety, and well-being of the residents of Rensselaer County; and

WHEREAS, The Dunn Construction and Demolition Landfill, approved and regulated by New York State, is located in extremely close proximity to the Rensselaer City School District campus, including approximately 200 feet from outdoor recreation areas and approximately 500 feet from school buildings; and

WHEREAS, The proximity of the landfill to the school community has generated serious and ongoing concerns regarding potential long-term health impacts on students, faculty, staff, and nearby residents; and

WHEREAS, Children are among the most vulnerable populations to environmental exposure and airborne contaminants, making comprehensive and site-specific air quality monitoring critically important; and

WHEREAS, Previous air monitoring efforts have largely relied on rooftop measurements and regional comparisons that do not adequately measure exposure conditions within the breathing zone of students, staff, and nearby residents; and

WHEREAS, Residents and advocacy groups have raised concerns regarding elevated volatile organic compounds (VOCs), black carbon emissions associated with truck traffic, potential PFAS contamination in landfill leachate, odors, dust, and other airborne contaminants associated with landfill operations; and

WHEREAS, The Rensselaer County Legislature believes additional targeted and transparent testing is necessary to properly evaluate air quality conditions in and around the landfill and surrounding neighborhoods; and

WHEREAS, The Legislature respectfully requests that the New York State Department of Health conduct comprehensive on-site, ground-level air monitoring at the Rensselaer City School campus and surrounding neighborhoods including East Greenbush, and fence-line monitoring at the landfill itself to directly measure emissions at the source; and

WHEREAS, The Legislature further requests testing for specific contaminants including PFAS, volatile organic compounds (VOCs), hydrogen sulfide, particulate matter, and other potentially harmful airborne toxins; and

WHEREAS, The Legislature also requests mobile air monitoring along Partition Street Extension, Van Rensselaer Drive, and nearby residential areas in East Greenbush that may be impacted by landfill operations and truck traffic; and

WHEREAS, The Legislature believes all testing data and findings should be publicly shared in a timely, transparent, and understandable manner to ensure residents have confidence that their air is safe; and

WHEREAS, The affected school population includes a significant percentage of minority, economically disadvantaged, and otherwise vulnerable students, making this issue directly relevant to the principles outlined in New York State's 2024 Health Equity Plan; and

WHEREAS, The Legislature believes that health equity requires targeted, community-specific action and that the unique conditions present in the City of Rensselaer—including the landfill's proximity to the school, prevailing wind patterns, and documented environmental concerns—warrant a heightened level of scrutiny and responsiveness from New York State; and

WHEREAS, The Legislature further believes that a comprehensive Health Equity Impact Assessment, including a longitudinal review of health outcomes where feasible, would provide valuable insight into any cumulative health impacts associated with landfill operations since 2015; and

WHEREAS, The Rensselaer County Legislature has consistently opposed the operation and expansion of the Dunn Landfill since its inception, while New York State has continued to approve and permit its operation; now, therefore, be it

RESOLVED, That the Rensselaer County Legislature hereby strongly urges the New York State Department of Health to immediately conduct comprehensive, on-site air quality testing and monitoring in the areas surrounding the Dunn Construction and Demolition Landfill and the Rensselaer City School District; and, be it further

RESOLVED, That the Legislature calls upon the New York State Department of Health to work collaboratively with local officials, school representatives, residents, and community stakeholders to address these ongoing public health concerns; and, be it further


