WHEREAS, Overdoses can occur in people who have an addiction to substances as well as those who do not, such as someone accidentally overdosing on prescription opioids after a surgery or an injury, an elderly person consuming too much of a prescribed pain reliever, a teenager experimenting with illegal drugs for the first time or a child ingesting opioid pills or powders from a home medicine cabinet or other storage location; and

WHEREAS, Residents can help prevent overdose deaths by being aware of the signs and knowing how to respond to an overdose. Rensselaer County has taken great measures to educate the public, make Naloxone (Narcan) available for county residents, as well as participate in collaborative efforts resulting in permanent prescription drop box locations and continued drug take back days so residents can dispose of unused medicines and prescription drugs; and

WHEREAS, Attendant to such duty and fully in accord with its long-standing tradition, it is the intent of this Legislative Body to express sincerest sorrow upon the death of Douglas Gregg Bucher, which occurred on Thursday, the Twenty-ninth day of June, of the year Two Thousand and Twenty-Three; and

WHEREAS, Respected and admired by all, it is the collective sense of this Legislature that the life of Douglas Gregg Bucher be memorialized and eulogized; and

WHEREAS, Douglas was born in Leonardtown, MD, the son of the late Robert Bucher and Marjorie Marie Miller; and

WHEREAS, Douglas attended Rensselaer Polytechnic Institute, School of Architecture and graduated in 1971. Soon after he joined the Peace Corps, where Douglas spent two-and-a-half years in Brazil designing renovations for hospitals; and

WHEREAS, Douglas returned to the United States and was offered the apartment in the back of the Rensselaer County Historical Society, now the Hart Cluett Museum; and

WHEREAS, Douglas was encouraged by then Director of the Rensselaer County Historical Society, Breffny Walsh, to talk to Jack Waite about working in historic preservation; and

WHEREAS, Douglas's passion was in the historic preservation field for fifty years, beginning with the New York Historic Trust before going into private practice, where he has worked for the past twenty-eight years; and

WHEREAS, Douglas had a knack for finding the story in a building, as well as their finishes and furnishings. Using his extensive knowledge he would trace the history and evolution of architecture. He also led the restoration of historic interiors, such as: the Kate Mullaney House in Troy; the New York State Capitol, and Alexander Hamilton's home; and

WHEREAS, In this time Douglas was an active member of multiple panels for historic preservation including: the Board of Directors of the Hart Cluett Museum, the Mary Warren Free Institute of Troy, and on Troy's Historic District and Landmarks Review Commission; and

WHEREAS, As a trusted board member Douglas regularly wrote articles for the Rensselaer County Historical Society. He co-authored with Stacy Pomeroy Draper the book, "Marble House in Second Street: Biography of a Town House and its Occupants, 1825-2000," which tells the history surrounding the Hart Cluett mansion and the people who have lived there; now, therefore be it

RESOLVED, That the members of the Rensselaer County Legislature adjourn this meeting in memory of Douglas Gregg Bucher, and extend our deepest sympathy to his family and friends, fully confident that his contributions to this community will live on to serve as a legacy to all; and, be it further
