## RESOLUTION AMENDING THE 2025 AND 2026 RENSSELAER COUNTY ADOPTED BUDGETS - DEPARTMENT OF PROBATION

**WHEREAS**, This Resolution is filed with the Rensselaer County Legislature by the Rensselaer County Executive; and

**WHEREAS**, Resolution G/107/24 authorized the acceptance of a grant award from the New York State Division of Criminal Justice Services ("NYSDCJS") for Pre-Trial Services, in the amount of \$314,288.00; and

**WHEREAS**, Such funding is to be used to offset the costs associated with the provision of certified pre-trial services for Rensselaer County, including but not limited to screening, assessment, supervision, and reporting; and

**WHEREAS**, This program has no defined term for spending the grant funds, but the Department must provide an overview of their spending plan to NYSDCJS within 60 days of receiving the award; and

**WHEREAS**, The total grant award has been received by the County as of January 12, 2024 with the Department budgeting \$314,288.00 of those grant monies in fiscal year 2024; and

**WHEREAS**, Resolution G/85/25 authorized the Department to roll over \$169,101.00 of unused funds from 2024 to the program's 2025 budget; and

**WHEREAS**, There are funds that were unused in 2025 which need to be rolled into the program's 2026 budget; and

**WHEREAS**, This program is fully funded by New York State monies and will produce no fiscal impact on Rensselaer County; now, therefore, be it

**RESOLVED**, That any positions, programs, expenditures, and/or agreements or contracts authorized or established pursuant to this Resolution shall terminate and cease upon discontinuance of said funding; and, be it further

**RESOLUTION AUTHORIZING AN AGREEMENT WITH VALSOFT CORPORATION INC. DBA  
HYPER-REACH TECHNOLOGY FOR AN INTEGRATED PUBLIC ALERT AND WARNING SYSTEM -  
BUREAU OF PUBLIC SAFETY**

**WHEREAS**, This Resolution is filed with the Rensselaer County Legislature by the Rensselaer County Executive; and

**WHEREAS**, The Rensselaer County Bureau of Public Safety ("BPS") operates Rensselaer County's Emergency Communications (911) Center and is responsible for providing timely, reliable emergency notification and staff recall capabilities to support public safety operations across the County; and

**WHEREAS**, BPS seeks Legislative approval to enter into an agreement with Valsoft Corporation Inc. dba Hyper-Reach Technology for an Integrated Public Alert and Warning System ("IPAWS") compliant Emergency Public Notification software platform for a one (1) year term at a cost not to exceed \$32,000.00; and

**WHEREAS**, Valsoft Corporation dba Hyper-Reach Technology located at 7405 Rte. Trancanadienne, Suite 100, Saint-Laurent, QC. H4T 1Z2, Canada, is a Federal Emergency Management Agency ("FEMA") IPAWS-compliant vendor, enabling Rensselaer County to issue both internal and public-facing emergency alerts rapidly and in accordance with federal standards; and

**WHEREAS**; BPS evaluated available vendors and proposals of these services with Valsoft Corporation Inc. dba Hyper-Reach Technology, an IPAWS and GSA Contract Vendor, contract GS-35F-072CA being selected as the most qualified provider which allows Rensselaer County's Emergency Communication Center to make instant internal team level and public mass notification emergency alerts as the need arises; and

**WHEREAS**, Hyper-Reach Technology is the only known vendor that provides direct integration with the Amazon Alexa application, allowing the County to expand emergency alerting capabilities into residents' home through voice-enabled devices, thereby improving the speed, reach and effectiveness of public notifications; and



**RESOLVED**, That any positions, programs, expenditures and/or agreements or contracts authorized or established pursuant to this Resolution shall terminate and cease upon discontinuance of said funding; and, be it further

**WHEREAS**, This Resolution is filed with the Rensselaer County Legislature by the Rensselaer County Executive; and

**WHEREAS**, Van Rensselaer Manor is seeking Legislative approval to enter into a five-year agreement with RetirementHomeTV Corporation, 4604 Arden Drive, Fort Wayne, IN 46804-4451, for the facility's bulk cable television services; and

**WHEREAS**, As part of the Van Rensselaer Manor facility renovation, Cable TV Services are being upgraded/replaced; and

**WHEREAS**, RetirementHomeTV Corporation will provide the nursing home with installation and cable television services over the course of each of the five phases of the renovation project simultaneously with each completed wing of the facility; and

**WHEREAS**, The Facility is seeking approval to enter into Phase 1 (of 5) agreement which covers Wing no. 1 and Wing no. 2 for the period commencing May 1, 2026 through April 30, 2031 for a cost of \$79,890.00; and

**WHEREAS**, Funding for the expense is built into the Facility's daily room rates (revenue) and budgeted through 2026 and future adopted budgets; and

**WHEREAS**, National Post Traumatic Stress Disorder (PTSD) Month is a campaign supported by the United States Department of Veterans Affairs; and

**WHEREAS**, Post Traumatic Stress Disorder (PTSD) is a mental health condition that's triggered by a terrifying event - either experiencing it or witnessing it; and

**WHEREAS**, PTSD significantly increases a person's risk for depression, suicide, drug and alcohol related disorders, as well as difficulties in maintaining interpersonal relationships and increased levels of violence; and

**WHEREAS**, Perceived or actual symptoms of post traumatic stress create challenges unique to Veterans related to social situations, successfully reintegrating following deployment, and obtaining and maintaining employment; and

**WHEREAS**, The brave men and women of our military have made tremendous sacrifices and have taken great risk to protect our freedoms, and deserve our resources and support to ensure their safety, and their physical, mental and emotional well-being; and

**WHEREAS**, In a personal context a set of Smart (Specific, Measurable, Achievable, Relevant, Time Bound) Goals are designed to regain control over ones life:

**Establish Safety:** Practice grounding techniques, such as the "5-4-3-2-1" method, for 5 minutes daily to manage acute anxiety.

**Commit to Action:** Dedicate 15 minutes each evening to journaling to process emotions and identify triggers.

**Build a Routine:** Maintain a regular sleep schedule and engage in 30 minutes of physical activity at least three times a week to improve emotional regulation.

**Stay Connected:** Commit to attending a weekly support group or reaching out to a trusted friend to reduce isolation.

## RESOLUTION CELEBRATING JUNETEENTH IN RENSSELAER COUNTY

**WHEREAS**, Juneteenth - also known as Freedom Day, Jubilee Day, Liberation Day, and Emancipation Day - is a holiday celebrating the emancipation of those who had been enslaved in the United States. Originating in Galveston, Texas, it is now celebrated annually on the 19<sup>th</sup> of June throughout the United States, with varying official recognition. It is commemorated on the anniversary date of the June 19, 1865 announcement by Union Army General Gordon Granger, proclaiming freedom from slavery in Texas; and

**WHEREAS**, Early celebrations involved church centered community gatherings, which spread across the South and became more commercialized in the 1920s and 1930s. When the Great Depression forced many Black people off their farms and into cities to find work, African Americans had difficulty taking the day off to celebrate. During the 1950s and 1960s, the Civil Rights Movement focused its attention on expanding freedom and integration for African Americans, and as a result Juneteenth celebrations dwindled again; and

**WHEREAS**, In the late 1970s the Texas Legislature declared Juneteenth a "holiday of significance (...) particularly for the Blacks of Texas," and Texas became the first state to establish Juneteenth as a state holiday; and

**WHEREAS**, In the meantime all 50 States and the District of Columbia recognize Juneteenth as a holiday or day of observance, with 31 States designating Juneteenth a permanent paid legal holiday through legislation or executive order; and

**WHEREAS**, The Juneteenth holiday is considered the "longest-running African-American holiday" and has been called "America's Second Independence Day". Juneteenth is usually celebrated on the third Saturday in June. Historian Mitch Kachun considers the end of slavery celebrations to have three goals: "to celebrate, to educate, and to agitate." The modern holiday places much emphasis on teaching about African-American heritage and instills a sense of heritage and pride in Black youth; and

**WHEREAS,** In 2020 New York State Governor Andrew Cuomo issued an Executive Order and declared Juneteenth as a holiday for state employees; and

**WHEREAS,** On June 17, 2021, President Joe Biden signed the Juneteenth National Independence Day Act (P.L.117-71) into law, which designates June 19 as a federal holiday; and

**WHEREAS,** Rensselaer County is proud of its history and being at the forefront in supporting, honoring and celebrating civil rights and freedoms; now, therefore, be it

**RESOLVED,** That the Rensselaer County Legislature is in support of the Juneteenth holiday and recognizes June 19, 2026 as Juneteenth Day in Rensselaer County.

## RESOLUTION URGING AN AMENDMENT TO NEW YORK STATE ASSEMBLY BILL A.6543 AND SENATE BILL S.5684 TO EXPAND THE NEW YORK BIGGER BETTER BOTTLE BILL AND OPPOSING THE INCREASE IN THE BOTTLE DEPOSIT FEE

**WHEREAS**, We all share a responsibility for keeping our communities clean and healthy; and

**WHEREAS**, This year marks the 43<sup>rd</sup> anniversary of the Bottle Bill. Signed into law by then-Governor Hugh Carey, it is New York's most effective recycling and litter reduction program; and

**WHEREAS**, The original Bottle Bill covered beer and soda containers only; and

**WHEREAS**, The Bottle Bill was updated in 2009 to include bottled water among the list of returnable containers; and

**WHEREAS**, Assembly Bill A.6543 and Senate Bill S.5684 seeks to further expand the list of returnable containers to include containers such as sports drinks, non-carbonated drinks, juices, teas, wine and spirits; and

**WHEREAS**, The expansion would allow a large number of containers that are currently sent to landfills to be recycled at redemption centers, as many landfills are approaching full capacity; recycling these containers would reduce the amount of trash going to those facilities; and

**WHEREAS**, This legislation would cut collection, sorting and disposal costs, and save local governments millions of dollars a year; and

**WHEREAS**, Hundreds of bottle redemption centers in the state have closed, because they weren't able to sustain the operation of their business. While adjustments to the handling fee may be warranted to support these businesses, the proposed 10 cent deposit fee would increase upfront costs to consumers; and

**WHEREAS**, Assembly Bill A.6543 and Senate Bill S.5684 seeks to increase the deposit fee for returnable containers from 5 cents to 10 cents, which has been stagnant since 1983; however, such an increase would place an additional financial burden on consumers, particularly during a time of rising costs; and while higher deposits may encourage returns, the Rensselaer County Legislature finds that doubling the deposit is not warranted; and

**WHEREAS**, The deposit is not a tax, as opponents like to suggest, as the deposit is returned by voluntarily bringing the containers back to the redemption center. It also helps informal recycling collectors who rely on deposit fees for their income, however, the initial out-of-pocket cost may still present a hardship for many residents; and

**WHEREAS**, Over its 40+ year history, New York's Bottle Bill has had a tremendous and positive impact on the environment, reducing roadside container litter by 70% and removing billions of cans and bottles from the waste stream; and

**WHEREAS**, States with bottle deposit laws have better recycling rates than non-deposit states. According to the Container Recycling Institute, states with bottle deposit laws have a beverage container recycling rate of 65%, while non-deposit states only reach about 24%; and

**WHEREAS**, Modernizing the Bottle Bill will reduce litter, increase recycling rates, reduce carbon emissions, and bring jobs to New York State; now, therefore, be it

**RESOLVED**, That the Rensselaer County Legislature supports the expansion of returnable containers as proposed by New York State Assembly Bill A.6543 and Senate Bill S.5684 and expressly opposes the provision increasing the deposit fee from 5 cents to 10 cents; and, be it further
