WHEREAS, This Resolution is filed by the Rensselaer County Legislature; and

WHEREAS, The Legislature previously authorized a contract for broadband service via Resolution G/345/20 and G/159/22 to add broadband to other county locations; and

WHEREAS, The County now desires to add broadband service to the Rensselaer County Sewer District, located at 1000 River Rd, 1st Floor, Troy, NY 12180; and

WHEREAS, The broadband service contract for the Sewer District was quoted in the amount of \$600.00 per month. The yearly contract amount is \$7,200.00. Service is available from Crown Castle Fiber, 46 Broadway, Menands, NY 12204 for a contract period of 60 months and is payable from account G.8130.04500; and

WHEREAS, The contract term for each service will take effect upon completion of any infrastructure buildout and account transition. This process will occur in stages to ensure a smooth transition with minimal service disruption; now therefore it be

WHEREAS, This Resolution is filed with the Rensselaer County Legislature by the Rensselaer County Executive; and

WHEREAS, The Legislature previously authorized a contract for broadband service via Resolution G/345/20; and

WHEREAS, The County desires to add broadband service to four (4) County facilities located at 1520 6th Ave, Troy, 25 Macha Lane, Wynantskill, 99 Troy Road, East Greenbush, and 14 Business Boulevard, Castleton-On-Hudson; and

WHEREAS, The original broadband service contract amount was approved for \$9,800.00 per month. The amended monthly contract amount is \$14,775.00. Service is available from Crown Castle Fiber, 46 Broadway, Menands, NY 12204 for a contract period of 60 months and is payable from account A.1680.04310; and

WHEREAS, The contract term for each service will take effect upon completion of any infrastructure buildout and account transition. This process will occur in stages to ensure a smooth transition with minimal service disruption; now therefore it be

RESOLUTION AUTHORIZING CONTRACTS FOR TELECOM AND BROADBAND SERVICES (BUREAU OF CENTRAL SERVICES AND BRIS)

WHEREAS, This Resolution is filed with the Rensselaer County Legislature by the Rensselaer County Executive; and

WHEREAS, In an effort to continually improve and expand services, the Bureau of Central Services has solicited quotes for telecom and broadband services for all county facilities as a result of continued service related interruptions and price escalation from current providers; and

WHEREAS, The department sought service quotations that maintained or increased service levels while maintaining or reducing current costs; and

WHEREAS, Three (3) proposals were received and reviewed for telecom and broadband services and the service providers that are being recommended are Crown Castle Fiber for broadband and BCM One, Inc. for telecom; and

WHEREAS, Both providers will meet the service needs of our county departments by increasing service speed and reliability while reducing service cost; and

WHEREAS, The broadband service is available from Crown Castle Fiber, 46 Broadway, Menands, NY 12204 for the amount of \$9,800.00 per month for a contract period of 60 months; and

WHEREAS, The telecom service is available from BCM One, Inc., 295 Madison Ave., 5th Floor, New York, NY 10017 for the amount of \$8,279.49 per month for a contract period of 60 months; and

WHEREAS, The contract term for each service will take effect upon completion of any infrastructure buildout and account transition, and this process will occur in stages to ensure a smooth transition with minimal service disruption; and

WHEREAS, The expenses for the above-noted services will be paid by various departments from budgeted appropriations; now, therefore, be it
