In accordance with Section 9-103 of the Act, the County is hereby authorized to enter into one or more energy performance agreements with Siemens Industry Inc. and related lease/purchase agreements with Siemens Public, Inc. (collectively the "Agreements") in an aggregate original principal amount not to exceed \$2,378,692.00, pursuant to which Siemens will provide equipment, capital improvements, repairs, ongoing preventative maintenance and other services to improve the energy efficiency of the 7th Avenue and State Street Rensselaer County Building, as more particularly described in the Agreements and the Facilities Improvement Measures, and to pay reasonable costs of issuance relating to the Agreements.

Section 2. RESOLUTION URGING THE STATE OF NEW YORK TO CONTINUE TO PASS-THRU FEDERAL AFFORDABLE CARE ACT ENHANCED FEDERAL MEDICAID ASSISTANCE PERCENTAGE FUNDS

WHEREAS, The SFY 2024 State Budget proposal would end the Affordable Care Act (ACA) enhanced Federal Medical Assistance Percentage (eFMAP) federal pass-thru to counties and New York City; and

WHEREAS, The State is proposing to end a 20 year precedent, and will keep all of these federal savings going forward, and use them to cover further expansions of Medicaid eligibility and benefits, and to increase payments to health care providers; and

WHEREAS, The elimination of this ACA eFMAP federal pass-thru will require the 57 counties to spend nearly \$300 million more in SFY 2024, and approximately \$1 billion when New York City is included; and

WHEREAS, The SFY 2024 costs to counties and New York City are scheduled to grow by 30 percent by SFY 2027; and

WHEREAS, It is the strong view of NYSAC that congress intended these federal savings to be shared with counties proportional to the amount they contributed toward the nonfederal Medicaid match; and

WHEREAS, Since 2003, the state has shared the funds proportionally based on an analysis of savings received during periods when an enhanced federal Medicaid match was enacted by Congress; and

WHEREAS, Enacted in 2011, the Medicaid statutory cap for all 62 counties is \$7.6 billion. The Medicaid statutory cap for the 57 counties outside of New York City is \$2.25 billion; and

WHEREAS, Starting in SFY 2014, New York began sharing these federal ACA savings directly with counties. The savings for a year were provided by lowering the weekly payments each county and NYC make to the state to support the State's Medicaid program. Through February 1, 2023, the state continues to share the federal savings from the ACA eFMAP with the 57 counties and NYC; and

WHEREAS, The 2023 theme is "Healing the Planet through Community": Recognizing that the prevention of sexual violence and supporting survivors is a shared responsibility among all community members. In addition, lifting the stigma around sexual assault will encourage victims to come forward and prosecute attackers and allow authorities to provide victims assistance and help to heal; now, therefore be it

RESOLUTION URGING NEW YORK STATE TO DIRECT GRANT MONEYS TO THE LEAD SERVICE LINE REPLACEMENT EFFORT IN THE CITY OF TROY

WHEREAS, A 2019 lead service line replacement plan report published by the New York State Department of Health shows 1,175 Troy children with elevated blood lead levels above 5 µg/dL over a five-year period; and

WHEREAS, Lead is a dangerous and pervasive neurotoxin for which there is no safe level of exposure or concentration, the impacts of which may impact speech, learning, attentiveness, antisocial behaviors, comas, convulsions, and even death; and

WHEREAS, Troy has detected such high levels of lead in its drinking water that it recently exceeded the US Environmental Protection Agency action level for lead; and

WHEREAS, Troy estimates that there are approximately 4,500 lead service lines throughout the City, each of which is estimated to cost \$5,000 to replace; and

WHEREAS, The constitutionality of raising revenue through taxes and fees to replace lead service lines is currently unresolved, and the constitutionality of using grant moneys to replace lead service lines is unambiguous; and

WHEREAS, Proposed increases to the City's water rate to finance the replacement of lead service lines would disproportionately impact the City's most financially precarious residents; and

WHEREAS, The Governor and State Legislature have appropriated \$4.5 billion for the Clean Water Infrastructure Act since 2017, which can provide grants for lead service line replacements at the discretion of the Governor; and

WHEREAS, The Governor has only allocated \$30 million in Clean Water Infrastructure Act funding for lead service line replacement since 2017, with no new lead service line replacement awards made since 2019; and

WHEREAS, There is over \$1 billion in Clean Water Infrastructure Act funding that has not yet been allocated to a particular program and which could be used for lead service line replacement; and

WHEREAS, New York State has access to additional grant funding for lead service line replacement through the federal Bipartisan Infrastructure Law, with \$115 million in grants and loans available this year; and

WHEREAS, In his State of the Union address, President Biden addressed this national health crisis and the importance of replacing lead pipes to ensure that all Americans have clean water to drink; and

WHEREAS, New Yorkers have a legitimate expectation that the municipal water from their taps will be clean and safe to drink, and that their children will be safe in their own homes; now, therefore, be it

RESOLVED, That the Rensselaer County Legislature urges New York State to direct Clean Water Infrastructure Act, Bipartisan Infrastructure Law, and other grant moneys to the City of Troy for the purposes of replacing the City's dangerous lead service lines expediently; and, be it further
