TENTATIVE SETTLEMENT AGREEMENT BETWEEN

RENSSELAER COUNTY AND THE RENSSELAER COUNTY SHERIFF'S OFFICE AND THE

COUNCIL 82, LOCAL 975 RENSSELAER COUNTY CORRECTION OFFICERS UNION

The following terms are for the purpose of achieving an extension of the current collective bargaining agreement through 2024. This settlement agreement has been ratified by the union membership. If the enclosed proposal is not ratified by the Sheriff and/or County Executive, and thereafter given legislative approval by the County Legislature, then it shall be considered withdrawn, null and void, and have no precedential value for further negotiations. Unless set forth herein or inconsistent with the purposes and intent of the terms set forth below, the terms of the agreement expiring on December 31, 2023 will be continued in the new agreement.

- 1. Term: January 1, 2023-December 31, 2023 (amendment only) and January 1, 2024 through December 31, 2024 (extension).
- 2. Wages:
 - A. Effective as soon as practicable following approval by the County Executive and Rensselaer County Legislature, each full-time unit member employed at the time payment is issued shall receive a one-time, lump sum bonus of \$2500.00. This payment will be pro-rated for employees who work less than standard full-time hours.
 - B. Effective January 1, 2023, 0.25% shall be added to the existing 1.75% increase.
 - C. Effective January 1, 2024, 2% will be added to the salary schedule.
- 3. There shall be no other changes to the collective bargaining agreement for the period January 1, 2023 through December 31, 2024.
