## RESOLUTION AUTHORIZING AN INTERMUNICIPAL AGREEMENT WITH THE TOWN OF SAND LAKE AND SAND LAKE AMBULANCE, INC.- BUREAU OF PUBLIC SAFETY

**WHEREAS**, This Resolution is filed with the Rensselaer County Legislature by the Rensselaer County Executive; and

**WHEREAS**, The Bureau of Public Safety seeks to enter into an intermunicipal agreement with the Town of Sand Lake and Sand Lake Ambulance, Inc. for Sand Lake Ambulance, Inc. to conduct a feasibility study regarding the potential merger of Sand Lake Ambulance, Inc. and North Greenbush Ambulance; and

**WHEREAS**, Rensselaer County has been awarded a grant from New York State for Local Government Consolidation Planning in the amount of \$25,000.00; and

**WHEREAS**, The grant will provide approximately fifty percent (50%) funding for the cost of the feasibility study regarding the potential merger of Sand Lake Ambulance, Inc. and North Greenbush Ambulance; and

**WHEREAS**, Sand Lake Ambulance, Inc. will facilitate the feasibility study, which will examine the operational, financial, and organizational aspects of a potential merger with North Greenbush Ambulance; and

**WHEREAS**, The feasibility study will be conducted for a total cost of \$51,475.00, with the grant providing \$25,000.00 toward the total, and the Town of Sand Lake paying the remaining balance of \$26,475.00 as the required local match; and

**WHEREAS**, The Town of Sand Lake will reimburse the County for the amount of the local match required by the New York State grant, and the County's role under the intermunicipal agreement is limited to the fiscal administration of the New York State grant; now, therefore, be it

**RESOLVED**, That the Rensselaer County Executive, or his designee, is authorized to sign the above described intermunicipal agreement, subject to the approval as to form by the Rensselaer County Attorney.
