WHEREAS, This Resolution is filed with the Rensselaer County Legislature by the Rensselaer County Executive; and

WHEREAS, The Department for Youth raises funds for the "Coats for Kids" program through a one-day golf event, the cost of which is completely funded by donations and player fees with net proceeds funding the coat drive; and

WHEREAS, A Request for Proposal (RFP-23-13) was prepared by the Bureau of Central Services in accordance with guidelines established in the Rensselaer County Purchasing Procedures; and

WHEREAS, The proposal submitted meeting Rensselaer County needs was received from The Country Club of Troy, PO Box 178, Troy, New York 12181. The anticipated golf tournament date is September 12, 2023 with an estimated contract amount of \$25,261.27; and

WHEREAS, The contract period is effective from the date of the signed Resolution and is renewable for four (4) additional renewals. Price increases will be evaluated on a year-to-year basis relative to the number of golfers upon each subsequent renewal; and

WHEREAS, The source of funding shall not exceed budgetary appropriations with funds utilized from Appropriation Code A.7310.04900; now, therefore, be it



LOCAL LAW #2, 1992
CERTIFICATION of COMPLIANCE

Local Law No. 2 for the Year 1992, adopted by the County of Rensselaer and effective as of September 1, 1992, provided for certain changes to the County's Code of Ethics, adopted originally in 1989. One of the changes provided for by the 1992 legislation affects those persons and entities who wish to do business with the County of Rensselaer and Hudson Valley Community College. In substance, the Code of Ethics, as amended, provides as follows:

"No elected public official or family member hereof, nor any partnership [or] unincorporated association in which he or she is a member or employee or in which he or she has a proprietary interest, nor any business or professional corporation of which he or she is an officer, director or legally or beneficially owns or controls more than five percent of the outstanding stock, shall have business dealings with Rensselaer County or any of its boards, agencies, commissions, authorities, districts and Hudson Valley Community College. For purposes of this subdivision, business dealings shall include contracts with Rensselaer County, its boards, agencies, commissions, authorities, districts and Hudson Valley Community College, gained through competitive bidding."

For the purposes of the above section, the term "family member" means "...a spouse, child, step-child, brother, sister parent, or dependent of Rensselaer County officer, employee, public official and party officers."

FEES & MINIMUMS

Golf Fee:

Eighty-Five (\$85.00) per player for 100 players or less.

Seventy (\$70.00) per player above 101

Minimum seventy players to close the golf course on a Monday or Tuesday (when permitted).

Meal Minimum:

Equal to the number of golfers plus any volunteers and/or vendors

Payment of the above fees entitles each event participant to one round of golf day of the event with use of 1/2 a golf cart and golf range. The event committee is responsible for payment of the minimum number of golfers and each meal. Any meals or golfers over the minimum will be charged at the per person rate.

FOOD AND BEVERAGE CONSIDERATIONS

- Specific details & pricing for food and beverage service will be developed with the CCT General Manager or Event Manager. Such details will be outlined in a separate agreement. Pricing is subject to change. Due to market fluctuations a final price of food & beverage will be provided within 30 days of the event.
- CCT will provide ALL food and beverage. Donations of food, beer, soda etc. are not permitted.
- The selling or disposing of all concessions are reserved to CCT. No outside concessions or licenses may be used without CCT authorization.
- All rules and regulations of the New York State Liquor Authority will be strictly enforced.
- For ordering & staffing purposes, CCT requires a final meal count *one week prior* to event.
- All food and beverage charges are subject to 18% gratuity and a 4% administration fee. The administration fee is

not a gratuity. This charge covers set-up and breakdown service, kitchen service, floor personnel and supervision. Applicable sales tax of 8% will be added to all charges other than gratuity.

- All food and beverage is to be consumed during the event while at the premises. There are no provisions for "to go" containers.

GOLF CONSIDERATIONS

- **Golf Carts:**
The Country Club of Troy has a maximum of 50 golf carts for participant use (100 golfers). Should a greater number of golf carts be necessary, the Golf Professional must be informed no later than 30 days in advance of the event. Tournament fleet golf cars are often in short supply, therefore CCT does not guarantee that additional golf carts can be obtained. When available, the event sponsor is responsible for payment of \$65.00 for each additional golf cart (minimum of 10), regardless of utilization.
- **Group Pairings:**
Lists of pairings, hole assignments, and/or tee times must be provided to CCT's Golf Staff no later than *72 hours prior* to the event.
- **Tee Signs and Tournament "Pin" Flags:**
The Club's staff will put in place your event's special tee signs, provided that, they are no larger than 24" x 36" and they are delivered to the Club's maintenance facility on stakes ready for placement no later than *72 hours prior* to your event. Your event committee is responsible for placement of large banners and other promotional materials. Tournament pin flags are to be no larger than 14" x 20" and must be delivered no later than *72 hours prior* to your event. Tube style pin flags are preferred.
- **Hole-In-One Contests & Prizes:**
Your event committee is responsible for complying with all provisions stipulated in Hole-In-One/Special Event Insurance Policies in effect for the event. This includes providing and positioning required witnesses and ensuring tee markers are set at the appropriate yardages. A copy of any such insurance policies, including yardage requirements, must be provided to the Golf Staff at least *72 hours* in advance of the event.
- **Dress Code:**
All participants shall wear appropriate attire on the golf course. Bathing attire, blue jeans, cut offs, tank tops, short shorts and undershirts are not acceptable.
- **Golf Spike Policy:**
Penetrating metal spikes are not permitted on the golf course.
- **Weather Policy:**
The event will be held rain or shine. CCT Golf Superintendent reserves the right to cancel the outing due to adverse course conditions. In event of cancellation, a reschedule date will be determined within same calendar year. Once participants start play, event will be considered final even if golf is discontinued at any point due to weather.

DEPOSITS AND PAYMENT

- A \$2,000 deposit is required with your signed contract to confirm your function. All deposits are non-refundable unless event is rescheduled within six months of event date. All events are considered tentative and unconfirmed without a signed contract and proper deposit. Deposit will be refundable *only* if CCT must cancel as stated below (item 14).
- Payment of 25% of total price based on the minimum guarantee shall be due 6 months prior to function date. A payment of 50% shall be due 30 days prior to the event.
- Final balance is due the day of the event. Acceptable forms of payment: cash, company check, personal check,

or money order. A 3% processing fee will be added to any amounts paid by credit card.

- Any residual charges, or if number of guests served was more than the guaranteed number, will be invoiced and payment is due within 15 days. Invoices over 15 days are/will be subject to late fees and/or finance charges.

TAX EXEMPT STATUS

For your organization to be considered tax exempt, New York State requires the following:

- A copy of your current exemption certificate issued by the State of New York 30 days prior to the beginning of your event.
- The exemption must be recognized and held valid by the State of New York; and
- The invoice is paid in full by funds of the organization in which the certificate is issued, upon the receipt of the billing statement.

CCT SPECIAL GOLF EVENT CONTRACT

- 1) Patron agrees to pay for all persons attending, but not less than, the number of guests guaranteed. CCT may limit service to the number of guests guaranteed. Arrangements for additional guests must be made one week prior to event.
- 2) Once confirmed, if Patron cancels the event, all sums paid in advance shall be retained by CCT as liquidated damages.
- 3) Premises shall be used only for the purpose hired.
- 4) Patron shall comply with all laws, orders, ordinances, and regulations of Federal, State, County and Municipal Authorities, and with any direction of any public officer which shall impose any duty upon CCT or Patron with respect to the premises engaged by the Patron or the use and occupation thereof.
- 5) Whenever a license or permit is required for Patron's function, the Patron, at their own expense, shall procure such license and/or permit from the proper authorities. Such license and/or permit must be left with CCT at least 14 days before the affair is to be held.
- 6) Any vendors, service providers or contractors, independent of the club, must be pre-approved by the General Manager. CCT must be listed as an additional insured on patron's insurance declaration for the date of the event and provided to CCT. This includes liability, workers' compensation, automobile and liquor liability, if applicable.
- 7) The selling or disposing of all concessions are reserved to CCT. This shall include, but not be limited to, soft drinks, candy, tobacco, liquor and/or checkroom. No outside concessions or licenses may be used without CCT written authority.
- 8) Patron shall take good care of the fixtures, furnishings, and real personal property in the premises. Patron assumes responsibility for any, and all damage to such property that it, its employees, guests, or invitee's may cause. CCT shall repair or replace, and the Patron agrees to pay the cost thereof.
- 9) Where the Patron is a corporation, unincorporated association, partnership or other legal entity, this agreement shall be binding on such legal entity.
- 10) Patron agrees that Patron will employ only employees of CCT on the premises or such employees authorized by the undersigned management of CCT.

- 11) Patron, in all respects, will comply with this contract and all the rules and regulations of CCT, its Board of Governors and CCT management.
- 12) CCT, or its agents, shall not be liable for any damage to property entrusted to its employees, nor for the loss of any property by theft or otherwise.
- 13) Patrons shall have free uninterrupted admission to and through premises limited to the area of the affair.
- 14) CCT shall have no responsibility for failure to supply any service when prevented from doing so by strikes, accidents or cause beyond CCT's reasonable contract or by orders and regulations or any governmental authority, or failure of all or other fuel supply, water, gas, electricity, air conditioning if any, or any other failure.
- 15) Patron agrees to indemnify and save harmless CCT, its servants and agents from any claims, liabilities, loss, demands, or actions whatsoever for any personal injuries, death, or property damages to any persons attending the affair hereby contracted for any reason or cause whatsoever even though arising from negligent acts or omissions and to reimburse CCT for any expenses or loss, up to and including reasonable attorney's fees and expenses incurred by reason of any such claim being made against CCT. Patron assumes the responsibility of so notifying all its employees, guests, visitors, and invitee's.
- 16) This agreement constitutes the entire contract between parties. No oral modification thereof shall be valid nor of any force or effect.
- 17) The person executing this contract expressly represents that he or she is of full age, and further, if an organization is named therein as Patron, that he or she is authorized to execute this contract on behalf of the said organization.
- 18) The CC of Troy agrees to service the function specified above and to render the additional services contracted for by Patron in accordance with the provisions of this contract.


